10. **QUESTIONS**

10.1 PLANNING APPLICATIONS/APPEALS

In response to the following question submitted by Comhairleoir C. Clancy, a written reply was circulated as outlined below:-

- (a) How many planning applications granted by Cork City Council Planning Department in 2007/8/9 were appealed to An Bord Pleanala.
- (b) How many appeals had Cork City Councils decisions overturned e.g. refused.
- (c) How many appeals had Cork City Councils decision upheld e.g. granted but with new conditions attached.
- (d) How many planning applications refused by Cork City Council Planning Department in 2007/8/9 were appealed to An Bord Pleanala.
- (e) How many appeals had Cork City Councils decision overturned e.g. granted.
- (f) How many were granted permission with new conditions attached.

10.2 CONTRACT RENEWAL FOR CLAMPING AND TOWING

In response to the following question submitted by Comhairleoir S. Martin, a written reply was circulated as outlined below:-

When was the contract for Clamping and Towing up for renewal? How much did the service cost Council in (1) 2006 (11) 2007 (111) 2008 (IV) 2009? Has the Council the right to change the list of offences that get you towed and clamped?

The towing and clamping contract with APCOA was renewed on the 1st January 2009. The contract period is three years.

The tender price for the previous tender (prior to 1^{st} January 2009), was approximately $\in 1.3$ million per year. The new contract had adjustments to towing periods, and as a result of the competitive tendering system, the cost in 2009 was $\in 1,000,900$.

Cork City Council has three available means of parking enforcement:

- Tow-away
- Clamping
- Fixed charge penalty notices (FCPN's or parking fines)

These enforcement means can be used for any of the parking offences listed in the Cork City Parking Bye-Laws and the National Parking Regulations. The actual use of any enforcement mechanism is determined by policy, e.g. at present it is Cork City Council's policy not to tow-away vehicles for disc parking offences.

10.3 FAIRFIELD IMPROVEMENT PROJECT

In response to the following question submitted by Comhairleoir M. O'Connell, a written reply was circulated as outlined below:-

Can the Manager tell me has the grant of 195,000 for the Fairfield Improvement Project from the dormant account fund been drawn down and can he outline how the money was spent?

The grant for enhancement works at the Fairfield is \in 195k, of which \in 58500 has been drawn down to date, further recoupment to be sought in the next week or so. Works to date include construction of a new perimeter walkway with enhanced entrances, with additional pathways and perimeter plinth wall works to be completed in the next few months.

10.4 SPORTING FACILITIES

In response to the following question submitted by Comhairleoir Ger Gibbons, a written reply was circulated as outlined below:-

Can the Manager please inform the Members what sporting facilities the City Council operates, directly and indirectly? What range of sports is catered for? How much revenue is raised? (i.e. pitch rental). How much expenditure is spent on upkeep of facilities? What is the average rent on a playing pitch? What are the plans in the next 12 months to add to these facilities?

The City Council provides the following sports facilities: 3 Swimming/Leisure Centres, Gyms/Aerobics studios An 18 hole Golf Course at Mahon All Weather Pitches - Bishopstown, Churchfield and Glen Resource Centre Basketball Courts- Clashduv and Kilmore Road Tennis Courts - Clashduv and Glen Resource Centre Sports Halls-Knocknaheeny and Tramore Road **Grass Pitches** Skate Park, Mardyke Pitch and Putt High Ropes and Zip Wire Courses Glen Resource Centre Multi User Games Areas in parks Athletics Track- contribute to CIT track Changing Pavilions Murphys Farm and Coffeys Field Togher Climbing Wall- Glen Resource centre Contributes to Mayfield Sports Complex annually

Range of Sports catered for

Field sports such as football ,hurling, soccer and rugby, indoor sports, basketball, golf, pitch and putt , swimming, athletics etc

How much revenue is raised(ie pitch rental) Pitches are leased/licensed to clubs at a nominal charge, as clubs are responsible for maintenance.

Expenditure on upkeep

As stated above, clubs using grass pitches are responsible for maintenance of same. In relation to the Golf Course, the nett operating cost is \notin 284k approx, with the Gus Healy Pool costing \notin 270k per annum. Leisureworld maintain the Bishopstown facility, with Glen Resource Centre Ltd being responsible for upkeep of the Resource Centre. Maintenance on other facilities varies from year to year but is generally very modest.

Plans in the next 12 months

The Council plans to develop 2 All Weather pitches at Togher, and a number of playing pitches at Inchigaggin.

10.5 **LONELY PLANET GUIDE**

In response to the following question submitted by Comhairleoir D. Cahill, a written reply was circulated as outlined below:-

With regard to recent recommendations by the World renowned "Lonely Planet Guide", highlighting Cork City, the Manager has in the past stated that a specific body will not be steering the marketing/branding of Cork City for 2010 and that Fáilte Ireland have been given the task of exploiting our city's award. Is there at least a written plan of marketing by Fáilte Ireland in this regard and if so can the Members view it? If no plan is written, would the Manager request Fáilte Ireland to give a presentation to Council outlining their strategy. 2010 will pass quickly and our city's chance to capitalize will pass also.

The organisation charged with promoting the tourism industry overseas is Tourism Ireland. In a letter to the Lord Mayor some time back Tourism Ireland confirmed that they were including the Lonely Planet coverage in their marketing and promotions.

Fáilte Ireland have also confirmed that they are also, in their promotional material, using the Lonely Planet accolade.

I will seek up-to-date details from Tourism Ireland and Fáilte Ireland.

10.6 <u>PLANNING PROCESS WHEN APPLICATIONS ARE MADE FOR FLOOD</u> <u>PLANES</u>

In response to the following question submitted by Comhairleoir L. McGonigle, a written reply was circulated as outlined below:-

To ask the City Manager, in light of the recent flooding throughout the city, if the appropriate experts (i.e. Hydrographers) will now be consulted during the planning process when applications are made for flood planes?

Issues concerning flooding have always been addressed by our engineering staff when considering significant planning applications in the city. The Department of the Environment issued Flood Risk Management Guidelines for Planning Authorities in November 2009. The Planning Directorate is currently considering the contents of the Guidelines with a view to their implementation into development management practice in Cork City.

10.7 **DEVELOPMENT CHARGES**

In response to the following question submitted by Comhairleoir J. O'Brien, a written reply was circulated as outlined below:-

Could you please supply me with the following information in relation to:

1. The total amount the local authority has collected from developers in development charges each year for the past five years.

- 2. The total amount developers have agreed to pay the local authority each year for the past five years.
- 3. The total amount that remains uncollected to date.
- 4. To state the amount of property given by developers in lieu of money owed and to provide details of same.
- 5. To provide a detailed list of debtors who owe money to the local authority for non-payment of development charges.
- 6. To provide details of any enforcement actions which have been taken by or on behalf of the local authority.
- 1. The total amount of receipts for development contributions for the last five years are as follows:
 - 2005 €11.0m 2006 €17.3m 2007 €21.3m 2008 €12.3m 2009 € 4.07m
- 2. Development contributions are levied in accordance with the General Development Contribution Scheme and the Supplementary Development Contribution Scheme. Cork City Council does not enter into agreements with developers with regards the amount of contributions to be paid.
- 3. The amount estimated for collection at the end of 2009 is \notin 2.46m.
- 4. The General Development Contribution Scheme and the Supplementary Development Contribution Scheme does not provide for property to be paid in lieu of monies owed. No property has been accepted in lieu of monies owed for development contributions.
- 5. As previously stated in a Council Question dated 27th April 2009, in accordance with the Data Protection Acts 1988 and 2003 the information requested cannot be made available as this legislation prohibits the disclosure of personal sensitive information in relation to living individuals & prohibits the disclosure of commercially sensitive financial information.
- 6. The legal mechanism available to Cork City Council for non payment of development contributions is to take Simple Contract Debt proceedings. Such proceedings have been initiated for outstanding development contributions in a total of 45 cases in the period 2008/2009.

10.8 FLOOD DAMAGE TO THE CORK MUSEUM

In response to the following question submitted by Comhairleoir K. McCarthy, a written reply was circulated as outlined below:-

Can the Manager please comment on the flood damage to the Cork Museum and when does he expect the Museum to re-open.

Extensive damage was caused to the Museum in the recent floods. In the old section, timber parquet flooring was damaged whilst in the new building all the mosaic flooring

has been compromised, plasterwork of walls and plinths damaged etc. There was no damage to the artefacts.

Following a period of investigative works and extensive drying out, works have commenced on relocating exhibits. Work associated with reinstating the damaged finishes in both the old and new sections of the Museum are due to commence shortly, with completion expected in late April.

10.9 **NATIONAL TREE WEEK**

In response to the following question submitted by Comhairleoir J. Kelleher, a written reply was circulated as outlined below:-

Bearing in mind that National Tree Week is approaching, will the Manager give a general outline of what is planned, including Tree Planting, Educational Projects and Special Events?

National Tree Week is being held between 7th- 13th March this year. In cooperation with the Zoology Department, UCC, the Council is arranging planting of native Irish tree species along the Mardyke Walk during the week. A tree exhibition is also being organized by the Council at the Lord Mayors Pavilion, Fitzgeralds Park, for the week, which will be open to schools and public.

10.10 VACANT AFFORDABLE HOUSING UNITS

In response to the following question submitted by Comhairleoir M. Finn, a written reply was circulated as outlined below:-

Could the Manager outline how many vacant affordable housing units are in the possession of Cork City Council, the location of same and the number of current applicants for these units, and how many people have taken up the shared-ownership option?

Cork City Council currently has 104 vacant units at the following locations:

Ard na Ri, Banduff, Ard Sionnach, Shanakiel, Kilbrack Lawn, Skehard Road, Coppinger's Acre, Bantry Park Road, Glentrasna Avenue, The Glen Hollyhill Heights, Hollyhill

A further disposal of 50 units under the Social Housing Leasing Programme is imminent. This will leave 54 units to be disposed of under the terms of the Affordable Housing Initiative.

At 31st December, 2009 Cork City Council had 1,256 affordable housing applicants.

In relation to the shared ownership scheme, Cork City Council, in 2009 received 14 applications and approved 14 applications. There were 4 shared ownership loans completed in 2009

10.11 PURCHASING AND LEASING OF RESIDENTIAL PROPERTIES

In response to the following question submitted by Comhairleoir J. Buttimer, a written reply was circulated as outlined below:-

With respect to the purchasing and leasing of residential properties by Cork City Council in 2007, 2008 & 2009, can the City Manager provide details regarding:

The number of residential units purchased in the time period. The type and nature of these properties (eg town house, semi-detached, apartment etc) The average purchase price of these properties. The number of residential properties leased in the given time period.

The type and nature of these properties (eg town house, semi-detached, apartment etc) The average lease cost per annum and the average length of contracted lease.

In response to items (i) to (iii) above, the details are as set out hereunder :

In response to items (iv) – (vi) above, excluding units leased under the Rental Assistance Scheme, please note that although negotiations took place with various Developers, Cork City Council Housing & Community Directorate have not entered into any leasing arrangements in respect of residential units, under the New Long Term Leasing Initiative, introduced by the Department of Environment & Local Government in 2009.

However, in response to a Press Notice in November 2009 Expressions of Interest in respect of Long Term Leasing have been received from individual house owners in respect of 57 residential properties within Cork City. At present these submissions are being assessed in order to ascertain their suitability to meet our housing needs.

10.12 FIRM(S) MAINTAINING THE PUBLIC LIGHTING IN THE CITY

In response to the following question submitted by Comhairleoir T. Brosnan, a written reply was circulated as outlined below:-

Can the Manager please publish the service level which Council and the public can expect from the new firm(s) now maintaining the public lighting in the city. Can he please confirm the names of those firms. For the benefit of Council and the public can he please confirm the relevant contact numbers to which faults can be reported.

The maintenance of the City Councils Public Lighting assets is undertaken primarily by Airtricity Utility Solutions, AUS who have taken over the ESB Contracts lighting maintenance business in Ireland. The detail with respect to service levels are the subject of negotiation between Cork City Council and AUS at present. The service levels will be incorporated into a new contract agreement that must also take account of all the issues including public liability, insurance, certification and auditing of work procedures on live networks.

Airtricity Utility Solutions also operate a Public Lighting Call centre on 1850 372 772 whereby members of the public can report lights that are Out of Order or faults occurring in the Munster area, including Cork City, directly to the contractor. The Airtricity facility is provided through the Abtran Call Centre with opening hours of 8:00am to 8:00pm from Monday to Saturday.

Please check the <u>number of the pole and the street name on which the light is located</u> before calling it in.

Customers may also e-mail in faults to <u>traffic@corkcity.ie</u> including street name and pole number in the e-mail.

ESB Networks operate a CallSave 1850 372 999 number for emergencies/electricity interruptions or to report emergency situations such as fallen power lines etc. ESB Networks will not respond to non-emergency fault reports such as public lights out or foliage blocking public lights.

10.13 PERMANENT TSB BRANCH ON CLASHDUV ROAD

In response to the following question submitted by Comhairleoir H. Cremin, a written reply was circulated as outlined below:-

Can the Manager inform Council about the status of the site of the Permanent TSB branch on Clashduv Road in Togher. This site was leased to the TSB (then Cork Savings Bank) in 1982. Does the Council currently retain an interest in this site and if so, what is the rent paid by TSB bank?

The site in question was sold outright to Cork Savings Bank (TSB) by way of Transfer dated 14th September 1981. Cork City Council does not retain an interest in the site.

11. <u>ADDRESSING FLOODING RISKING– LEE CFRAMS –</u> CATCHMENT FLOOD RISCK MANAGEMENT PLAN

FULL TIME SWEEPER IN THE GLEN

'That a full time sweeper be deployed to the Glen in the following areas: Comeragh Park, Avoca Crescent, Coolamber Drive, Imall Court, Errigal Heights, Mourne Avenue, Arderin Way and Mangerton Close.'

(Proposer: Cllr. K. O'Flynn 09/195)

The report of the Director of Services, Environment stated that the indication of a temporary manual sweeper who was assigned to the Mount Farran area was not replaced when his contract came up for renewal in line with the policy of non replacement of staff and that it would not possible to provide a manual sweeper for the areas mentioned in the motions. These areas are swept once a week by suction sweeper which is the norm for suburban areas.

15.4 TEXT WARNING SYSTEM FOR POTENTIAL FLOODING

An Chomhairle approved the report of the Director of Services, Environment on the following motion which was referred to the Committee by An Chomhairle:-

'That Cork City Council would establish an opt-in text warning system for potential flooding and that it would be offered to residents living in identifiable flood risk areas.'

(Proposer: Cllr. J. Buttimer 10/01)

The report of the Director of Services, Environment stated that currently the City Council operates a limited flood alert system, geared primarily, at advising on tidal flooding, which, most regularly impacts on the Centre Island commercial areas. The alert is advised through the media and business representative groups.

The November 09 flood which was caused by river overflow and had little tidal input highlighted need for review of flood alert procedures.

The Lee Catchment Flood Management Plan, due shortly from the Lee CFRAMS project, is expected to recommend development of a flood forecasting and warning system by the OPW, in conjunction with Cork City and County Councils and other appropriate bodies. Methods of delivery of alerts including opt-in text can be considered as part of this process.

15.5 **NEW FLOOD WARNING SYSTEM**

An Chomhairle approved the report of the Director of Services, Environment on the following motion which was referred to committee by An Chomhairle:-

'That Cork City Council would in conjunction with relevant stakeholders e.g. the ESB, MET Éireann and others, seek to develop a new flood warning system which would give greater predictive accuracy and would develop a new graduated warning system that could be tailored for localized areas.'

(Proposer: Cllr. J. Buttimer 10/02)

The report of the Director of Services, Environment stated that the City Council operates a limited flood alert system, geared primarily, at advising on tidal flooding, which, most regularly impacts on the Centre Island commercial areas. The alert is advised through the media and business representative groups.

The November 09 flood which was caused by river overflow and had little tidal input highlighted need for review of flood alert procedures.

The Lee Catchment Flood Management Plan, due shortly from the Lee CFRAMS project, is expected to recommend development of a flood forecasting and warning system by the OPW, in conjunction with Cork City and County Councils and other appropriate bodies including ESB, Met Éireann.

- All individuals or companies tendering must be tax compliant and meet all local and national approval in standards and codes.
- Council would have to make approval within three days of the application.'
