The Lord Mayor proposed and it was agreed to extend congratulations to the Parks Department and to the organisers of the Equilibrio Sculpture Project undertaken with Cork's twin city of Cologne.

The Lord Mayor proposed and it was agreed to extend congratulations to the organisers of "Peacock and Swan" a celebration of Chinese New Year at which the Chinese Ambassador had attended.

The Lord Mayor informed An Chomhairle of his proposed visits to the twinned cities of Cologne and Shanghai.

#### 3. QUESTIONS

# 3.1 <u>ACTIONS TAKEN TO FIXING SEWERAGE LEAKS IN O'CONNELL AVENUE</u>

In response to the following question submitted by Comhairleoir S. Martin, a written reply was circulated as outlined below:-

Could the Manager outline what actions were taken in relation to the fixing of sewerage leaks in?

#### 1A O'Connell Avenue

Junction of Evergreen Street and Abbey Street?

The property at **1A O'Connell Avenue\_**is not owned by Cork City Council. A drain leak from this property into an adjoining one was reported to the Council in March 2009. An Council engineer called to the site and spoke to the complainant. It is understand the complainant's legal representatives had written to the site owner but received no response. It was explained that the matter was a private one and there has been no further communication on the matter with the Council.

Section 70 of the Water Services Act 2007 places a duty of care on the occupier of a premises, or if unoccupied, on the owner, to ensure that wastewater from the premises does not cause nuisance or risk to human health or the environment. Legislation was commenced on 30<sup>th</sup> April 2009 bringing subsections (6) and (7) of Section 70 into operation. These subsections provide a procedure for complaint to the District Court by any person affected by non-compliance with a duty of care under section 70.

Cork City Council investigated a complaint received on 28<sup>th</sup> August 2009 in relation to a property located at the junction of **Evergreen Street and Abbey Street.** There was a large spillage occurring on the public roadway. A Council engineer called to a number of houses in the vicinity and discovered a blockage in a common drain. The engineer

contacted the landlady of the premises in question and informed her of her responsibility and duty of care. Letters were sent to the occupiers of adjoining properties who shared the drain, requesting them to take joint action or risk legal proceedings being taken. A phone call was received by the engineer subsequently informing him that the problem had been found and it was being addressed.

#### 3.2 COUNCIL'S POLICY ON DOG FOULING

In response to the following question submitted by Comhairleoir L. McGonigle, a written reply was circulated as outlined below:-

Can the Manager outline the Council's policy on dog fouling?

This issue has been raised a number of times in Council and numerous reports have been issued, but to little effect. The problem of dog fouling is city wide, and one that is not being tackled, given that no prosecutions or fines have ever been issued.

In his reply, can the Manager outline how it is policed and how many wardens are working in the suburbs?

Cork City Council implements the 1997 to 2003 Litter Pollution Acts. It is an offence under section 22 of the 1997 Act in failing to remove faeces deposited by a dog. The on the spot fine is epsilon150 with a maximum court fine of epsilon3,000.

Cork City Council litter wardens can issue a fine under this section if they observe a dog in the act of fouling and can identify the owner or person in charge of the dog. Cork City Council can also issue fines if members of the public can provide specific details of dog fouling and are prepared to act as witnesses in any court hearings.

Cork City Council has erected signs in various areas of the city outlining the fines for failure to remove dog faeces and dog receptacle units have been installed in a number of parks and walkways throughout the city. All dog licence holders have been written to on responsible dog ownership including removal of dog faeces. In addition bags for the disposal of dog faeces have been provided to all dog licence holders.

Cork City Council has a staff compliment of 1 litter warden supervisor and 3 litter wardens.

Following discussion An tArd Mhéara proposed and it was agreed that he would write to the Chair of the Joint Policing Committee in relation to enforcement issues pertaining to lower level legal infringements such as dog fouling, illegal use of bus lanes, etc. and that there was need for a public awareness campaign in relation to dog fouling.

# 3.3 <u>SERVICES THAT ARE BEING ASSESSED AS TO THEIR LIABILITY FOR</u> VAT IN THE WAKE OF FINANCE BILL

In response to the following question submitted by Comhairleoir M. Barry, a written reply was circulated as outlined below:-

Can the Manager provide Council with a comprehensive list of the services that are being assessed as to their liability for VAT in the wake of the recent Finance Bill?

The European Court of Justice (EDJ) in July 2009 delivered its judgment in a case against Ireland in respect of the charging of VAT by public bodies on certain economic activities. The judgment has implications for all public bodies in Ireland, including local authorities.

Provisions to give legal affect to this is included in the Finance Bill 2010.

The main effect of the judgment for the City Council is that VAT must be applied to all local authority services where competition with private sector services providers exists or where such competition could occur.

At present each local authority is carrying out a review of the services they provide to determine which are outside the scope of VAT, which are taxable and which are exempt.

A working group is being established involving the Department of Environment, Heritage and Local Government, the Department of Finance and the Revenue Commissioners. This will review the services list, agree the classification of the items and in conjunction with the Revenue Commissioners agree VAT rates applicable.

It is too early to determine the full scope at this point but Refuse Collection & Disposal and Off-street Parking will be subject to VAT. It should be noted that Water and Waste Water charges are exempt from VAT as per Finance Bill.

#### 3.4 EMERGENCY VEHICLES OWNED BY CORK CITY COUNCIL

In response to the following question submitted by Comhairleoir J. Buttimer a written reply was circulated as outlined below:-

Can the City Manager indicate how many emergency vehicles owned by Cork City Council have a snorkel exhaust system and if there has been any review of the emergency response fleet following the recent flooding and severe snow and frost conditions?

A snorkel exhaust system is not fitted to any emergency vehicles in Cork City Fire Department or Cork City Civil Defence. Due to the inherent dangers of driving through flood conditions i.e. the risk of hidden obstacles, fast flowing water, variable water depths and the risk of consequential damage to vehicles, property and personnel, the best and most appropriate mode of transport in flooded areas is by boat. Following the recent Severe Weather events the emergency response fleet was examined and any necessary repairs carried out.

# 3.5 <u>MAKE CONTACT WITH THE DEVELOPER OF ARD PARTICK, ASSUMPTION HILL</u>

In response to the following question submitted by Comhairleoir C. Clancy, a written reply was circulated as outlined below:-

To ask the Manager:

That Cork City Council in the interest of proper planning and public safety make contact with the Developer of Ard Patrick, Assumption Hill, (Blackline Properties), the Developer of Knockanuss Popes Road, Fingerpost Builders Ltd - to have the wall dividing the 2 estates which has an excessive drop onto Ard Patrick made safe before the estates are taken in charge.

The wall between the Ard Patrick and Knockanuss estates was recently inspected by our Building Control Officers. The wall in question is not a dangerous structure which would require action under the Local Government Sanitary Services Act 1964.

The wall also complies with the Building Regulations 1997 and 2000. It will be inspected by the City Councils Parks Department section prior to being taken in charge in due course when any necessary revision of ground levels can be considered.

# 4. <u>ROADS & TRANSPORTATION FUNCTIONAL COMMITTEE - 7<sup>th</sup> DECEMBER</u> <u>2009</u>

#### 4.1 **ROADWORKS PROGRAMME**

An Chomhairle considered and approved the report of the Assistant City Manager, dated 4th February, 2010, on the Interim Report on Cork City Transport Plan - Transport Issues.

# 4.2 REPORT ON MAHON TRAFFIC AND TRANSPORTATION STUDY

An Chomhairle considered and approved the report of the Assistant City Manager, dated 4th February, 2010, on Mahon Traffic and Transportation Study.

#### 4.3 **REVIEW POLICY OF CLAMPING CARS**

An Chomhairle considered and approved the report of the Assistant City Manager, dated 4<sup>th</sup> February 2010 on the following motion which was referred to the Committee by An Chomhairle.

'That Cork City Council review its policy of clamping cars, other than those that are interfering with the flow of traffic and are a danger to pedestrians, in the interest of fairplay for motorists and businesses in the city.'

(Proposer: Cllr. C. Clancy 09/258)

The report of the Assistant City Manager stated that, Cork City Council has three means of parking enforcement:

- Tow-away
- Clamping
- Fixed charge penalty notices (parking fines)

Fines are not a deterrent to many illegal parkers and the introduction of clamping and tow-away some years ago has greatly improved the compliance levels of the parking regulations. The results were:

- ➤ The turnover of disc parking spaces doubled in some areas, resulting in increased availability of parking in the City Centre.
- ➤ Public safety improved with reduced parking on footpaths, near pedestrian crossing facilities and adjacent to junctions.
- Bus stops, taxi ranks, disabled spaces are kept clearer.

Illegal parking resulting in traffic congestion and a poor road safety environment lessens the attractiveness of the city centre for shoppers, visitors, employment centres, etc. Vehicles which interfere with the flow of traffic or are causing a danger to pedestrian and other road users should be towed away. Clamping these vehicles could result in the danger and obstruction be prolonged for a longer period than it should.

Relying on fines only for the enforcement of disc parking area would be a retrograde step and would result in a reduced availability of parking on the street which ultimately will affect the attractiveness of the City Centre as explained above. Accordingly, it is recommended that the policy of using the three currently available enforcement tools in an appropriate manner be retained.

#### 4.4 **CLAMPING POLICY**

An Chomhairle considered the following motion:

'That Cork City Council immediately stops its policy of clamping vehicles without valid parking discs in designated parking zones and instead increase fines and reserve the practice of clamping for vehicles parked on double-yellow lines, loading bays or those that cause obstruction for other vehicles, including emergency services.'

(Proposer: Cllr. M. Finn 09/271)

On the proposal of Comhairleoir M. Finn, seconded by Comhairleoir C. Clancy, a vote was called for on whether to accept the report of the Assistant City Manager, dated 4<sup>th</sup> February 2010 on the above motion where there appeared as follows:

An tArd Mhéara declared the vote carried and the report of the Assistant City Manager rejected and referred same back to the Roads & Transportation Strategic Policy Committee.

#### 4.5 PARKING PERMITS AND BLUE BADGE PARKING PERMITS

An Chomhairle considered and approved the report of the Assistant City Manager, dated 4<sup>th</sup> February 2010 on the following motion which was referred to the Committee by An Chomhairle.

'To review both parking permits and blue badge parking permits, as excessive parking usage i.e. all day parking and multi permit per household is badly affecting turnover of parking in the city.'

(Proposer: Cllr. D. Cahill 09/326)

The report of the Assistant City Manager stated that, disabled driver of "blue badge" permits are issued only by The Irish Wheelchair Association and The Disabled Drivers Association. New regulations will be issued soon by the Minister of Transport to update the current situation and to ensure that disabled driver parking bays are only available to those most impaired in their immobility. This is being done in the background of over 80,000 permits in existence in the Country, which is regarded as excessive.

There are over 100 disabled driver spaces in the City Centre which is in line with current guidelines, i.e. 5% or more of current on-street spaces. All multi-storey car parks also have disabled driver spaces close to lift areas, etc. The issue of allowing disabled drivers to park free in all disc parking areas will be reviewed, because although it may be argued that disabled drivers might be less well financially off than the general public, this practice makes the holding of a permit extremely attractive and opens it to widespread abuse. Many on-street spaces are occupied for long periods as a result of the disabled driver badges displayed and this has an overall effect on the availability of car spaces and the attractiveness of the City Centre to visit, shop in, etc.

Providing parking permits for residents in the City Centre is a long standing policy of Cork City Council to maintain the City Centre as an attractive place to live in. This is critical for the safety and economic well being of the City Centre, and it is recommended that this policy does not change. Multi permits (max. four allowed) cater for rental properties where there may be several adults living together or where families have grown up children with cars. This arrangement should not change.

# 4.6 <u>HIGHLIGHT DISABLED PARKING SPACES</u>

An Chomhairle considered and approved the report of the Assistant City Manager, dated 4<sup>th</sup> February 2010 on the following motion which was referred to the Committee by An Chomhairle.

'That all designated disabled parking spaces in Cork City be highlighted in medical blue paint and the white wheelchair symbol, as this is recognised practice in E.U. Countries.'

(Proposer: Cllr. K. O'Flynn 09/126)

The report of the Assistant City Manager stated that, all designated disabled driver parking spaces are marked by the white wheelchair symbol and with additional signage on nearby poles. The combination of the signage and road markings makes them very prominent and visible. In a few cases the road is also painted blue, however it is not practice to do this because of the large cost involved in providing and maintaining the blue plastic paint.

The Department of Transport is at present preparing guidelines for the designation of disabled parking spaces, including the parking of parking bays in 'blue'. On publication of the guidelines in 2010, we will review our policy in this case.

# 4.7 <u>SIMPLIFY PROCESS FOR RESIDENTS PARKING PERMITS</u>

An Chomhairle considered and approved the report of the Assistant City Manager, dated 4<sup>th</sup> February 2010 on the following motion which was referred to the Committee by An Chomhairle.

'That Cork City Council in an effort to further deliver on its customer charter, simplifies the application process for resident's parking permits and in particular removes the excessive 'red tape' for existing permit holders who wish the renew.'

(Proposer: Cllr. M. Finn 09/331)

The report of the Assistant City Manager stated that, in order to be granted a resident's permit, a customer must prove that they are a resident within a disc parking area and own a vehicle. Currently, the proof required includes a copy of the Vehicle Licensing Certificate/Log Book for the vehicle; two recent domestic utility bills in the applicant's name for the address in question; and copies of the applicant's insurance certificate and driver's licence. Those who are not on the register to vote from the address for which the parking permit is being sought must complete a declaration in the presence of a Peace Commissioner/Commissioner for Oaths/Practising Solicitor. Applicants living in rented accommodation must also submit a copy their Rent Book/Rental Agreement and a confirmation letter from the Private Residential Tenancies Board (PRTB).

While these requirements may seem onerous, they are necessary to ensure that only those who are validly entitled to a permit receive them, and therefore to ensure that the parking spaces in a given area are available to genuine residents. It is the abuse of 'free' parking by commuters which is the prime factor in introducing pay parking controls in a residential area. Given the annual fee is only €10, there is a danger that relaxing the strict eligibility criteria will lead to abuse of the resident's permit system to the detriment of genuine residents.

The issue will be examined in greater detail when the Cork City Council Parking Bye Laws are reviewed in early 2010 and in particular the issue of possibly simplifying the application process for those submitting repeat yearly applications.

# 4.8 <u>ABOLISHING CLAMPING VEHICLES</u>

An Chomhairle considered and approved the report of the Assistant City Manager, dated 4<sup>th</sup> February 2010 on the following motion which was referred to the Committee by An Chomhairle.

'That Cork City Council should now seriously consider abolishing clamping vehicles in designated car parking spaces in the City, to encourage shoppers back in to the City Centre, who were in fear of being clamped and would shop in suburban centres to avoid City parking.

Can the Manager also outline in his report on this motion the current contract arrangements and fees paid to contractors and the number of vehicles clamped and the value of clamping fees collected in 2008.

Could he also set out the protocols agreed and in place under the current clamping regime?'

(Proposer: Cllr. K. O'Flynn 09/128)

The report of the Assistant City Manager stated that, Cork City Council has statutory responsibility for the enforcement of parking regulations, as defined under the Roads Traffic Acts 1961 to 2004, within the Cork City Council administrative area. The Garda Siochána who are the national police force also have statutory powers as regards enforcement. The City Council has appointed APCOA Limited for a 3 year period covering the years 2009-2011. APCOA were required to establish, manage and enforce both a vehicle immobilisation (clamping) and vehicle removal (towing) service. The city-wide operation incorporates a comprehensive service of removal, storage/release, clamping/de-clamping, issuing and processing of notices to vehicles removed or clamped, processing of payments received for vehicle release/de-clamping, assessment and disposal of unclaimed vehicles and associated administrative work.

The contact fee paid to APCOA in 2008 for the immobilization and towing-away of vehicles was €1,343,044.69. This tender fixed sum includes an approximate amount of €310,000 for the clamping of vehicles element. Number of vehicles clamped in that period was 5,469. The corresponding value of clamping fees collected was €428,595. The income from towing fees in 2008 was € 503,654.62.

The immobilisation of vehicles occurs as a result of identification of illegally parked vehicles reported by APCOA Limited's own spotters or as a result of illegally parked vehicles being reported by Cork City Council's Traffic Warden Service to APCOA Limited. The service operates from Monday to Saturday during the period 08.30 to 18.30 hrs.

Fines are not a deterrent to many illegal parkers and the introduction of clamping and tow-away some years ago has greatly improved the compliance levels of the parking regulations. The results were that the turnover of disc parking spaces doubled in some areas, resulting in increased availability of parking in the City Centre

Relying on fines only for the enforcement of disc parking areas would be a retrograde step and would result in a reduced availability of parking on the street which ultimately will affect the attractiveness of the City Centre as explained above. Increasing fines is not an option for Cork City Council as this is controlled at national government level. The parking fine was increased from  $\in$ 19 to  $\in$ 40 in the recent past and it is unlikely that it will be increased in the near future.

#### 4.9 FREE PARKING IN THE CITY CENTRE ON SATURDAYS

An Chomhairle considered and approved the report of the Assistant City Manager, dated 4<sup>th</sup> February 2010 on the following motion which was referred to the Committee by An Chomhairle.

'That Cork City Council on a pilot basis introduce free parking in Cork City Centre on Saturdays. That Cork City Council introduce a food market day on one Sunday a month utilising Patrick Street, making it car free. We need to introduce programmes to enhance people back into the City Centre.'

(Proposer: Cllr. S. Martin 09/313)

The report of the Assistant City Manager stated that, there are eight multi-storey car parks available to the public in the City Centre. The City Council owns and operates two; Paul Street and North Main Street Car Parks. Providing free car parking on Saturdays, which is far the busiest day, would have financial implications and would result in a serious loss of income to the City Council. It is proposed therefore that free parking on Saturdays in the multi-storey car parks will not be provided.

In relation to on-street parking, it is also proposed that no change be made to current arrangements. On-street parking facilities are for those who wish to spend a relatively short time in the City Centre and it is important that a constant turnover of spaces occurs. If the parking was free, these spaces would be filled very quickly in the morning by city centre workers. This was the case in the 1970's before pay parking controls were introduced.

No turnover of spaces would occur during this period and effectively the availability of on-street spaces in the prime shopping areas for potential shoppers/visitors would reduce to close to zero. This would lessen the attractiveness of the City Centre to these people and the outcome would be the opposite as intended.

The proposal of making St. Patrick's Street car free would require comprehensive consultations with the City Centre Traders, Bus Éireann, Taxi Operators and the Gardaí. Several major bus routes use the street and alternative arrangements for bus routes and bus stops would have to be implemented. The taxi operators would also have to be accommodated. Discussions will be held with the relevant stakeholders and a further report on the outcome of the consultations will be made to Council.

Over recent years Cork City Council has been organising outdoor markets in association with special events taking place in the city, such as the Jazz Festival and the Christmas Winter Garden. The number of markets being held has grown considerably and they have contributed positively both to the events themselves as well as the city in general. The markets held on the newly redeveloped Grand Parade have been particularly well received. The space there is considered more amenable to occasional market trading activity and is favoured by the market organisers.

The proposed upgrading of Cornmarket Street will provide a greatly enlarged purposebuilt market space with a potential to serve increased levels of open markets, including food markets. The overall situation with regard to open markets will be reviewed before Cornmarket Street becomes available and the issue of a regular Sunday Market will be examined as part of this review. At this stage a monthly Sunday Market on Patrick Street would not be considered practical.

#### 4.10 **ROAD RESURFACING**

An Chomhairle considered and approved the report of the Assistant City Manager, dated 4<sup>th</sup> February 2010 on the following motion which was referred to the Committee by An Chomhairle.

'That Cork City Council adopt as policy the concept of notifying all Public Utilities in advance of all Public Road Resurfacing Contracts with a view to ensuring all proposed works be done by these utilities in advance of resurfacing. There after except for emergency a heavy financial penalty would ensure to cover the cost of proper resurfacing following the road opening.'

(Proposer: Cllr. S. Martin & Cllr. D. O'Flynn 09/354)

The report of the Assistant City Manager stated that, during the design process for resurfacing/paving contracts all Public Utilities are contacted/reminded of the impending works so that they can carry out any necessary works prior to the resurfacing/paving Contract. There are onerous conditions attaching to any Public Utility works on a road that has been recently resurfaced in order to ensure that their works are carried out prior to resurfacing.

# 5 ROADS & TRANSPORTATION FUNCTIONAL COMMITTEE – 8th FEBRUARY 2010

# 5.1 **ROADWORKS PROGRAMME**

An Chomhairle considered and approved the report of Assistant City Manager, dated 4th February, 2010 on the progress of ongoing Roadworks Programme for month ended January, 2010.

# 5.2 TAKING IN CHARGE OF "ASHMOUNT" & "SOUTHRIDGE", MAYFIELD, CORK HOUSE NOS. 1-98 AT "ASHMOUNT", HOUSE NOS. 1-28 AT "SOUTHRIDGE", HOUSE NOS. 39, 40, 41 AND 42 SILVERSPRINGS COURT

An Chomhairle considered and approved the report of Assistant City Manager, dated 4th February, 2010 regarding the taking in charge of "Ashmount" & "Southridge", Mayfield, Cork - house nos. 1-98 at "Ashmount", house nos. 1-28 at "Southridge" and house nos. 39, 40, 41 and 42 Silversprings Court.

The report of the Assistant City Manager stated that, "I refer to development at "Ashmount" & "Southridge", Mayfield, Cork.

In accordance with Section 11 of the Roads Act 1993, and in compliance with Section 180 of the Planning and Development Act 2000, notice of intention to declare roads, open spaces, car parks, sewers, water mains or service connections, at "Ashmount" & "Southridge", Mayfield, Cork {House Nos. 1-98 at "Ashmount", House Nos. 1-28 at "Southridge", House Nos. 39, 40, 41 and 42 Silversprings Court}, to be public roads,

open spaces, car parks, sewers, water mains or service connections was published on 7th December, 2009.

Objections or representations with regard to this proposal were invited. None were received.

The roads, open spaces, car parks, sewers, water mains or service connections are of general public utility. The financial implications of declaring these roads to be public roads, open spaces, car parks, sewers, water mains or service connections has been considered.

Subject and without prejudice to the elected Council's consideration of the written representations or objections received within the prescribed statutory period set out in section 11 (1) (b) of the Roads Act, 1993, I now recommend that this report be referred by the Roads and Transportation Functional Committee to Council for approval and that this Committee recommend the following resolution to Council for adoption;

An Chomhairle considered and approved the report of Assistant City Manager, dated 4th February, 2010 regarding the taking in charge of "College View", off Cahergal Lawn,

Old Youghal Road, Cork - 16 No. Houses, (1-7 on Old Youghal Road) and (8-16 off Cahergal Lawn).

The report of the Assistant City Manager stated that, "I refer to development at "College View", Off Cahergal Lawn, Old Youghal Road, Cork.

In accordance with Section 11 of the Roads Act 1993, and in compliance with Section 180 of the Planning and Development Act 2000, notice of intention to declare roads, open spaces, car parks, sewers, water mains or service connections, at "College View", Off Cahergal Lawn, Old Youghal Road, Cork {16 No. Houses, (1-7 on Old Youghal Road, 8-16 off Cahergal Lawn)}, to be public roads, open spaces, car parks, sewers, water mains or service connections was published on 7th December, 2009.

Objections or representations with regard to this proposal were invited. None were received.

The roads, open spaces, car parks, sewers, water mains or service connections are of general public utility. The financial implications of declaring these roads to be public roads, open spaces, car parks, sewers, water mains or service connections has been considered.

Subject and without prejudice to the elected Council's consideration of the written representations or objections received within the prescribed statutory period set out in section 11 (1) (b) of the Roads Act, 1993, I now recommend that this report be referred by the Roads and Transportation Functional Committee to Council for approval and that this Committee recommend the following resolution to Council for adoption;

View", Off Cahergal Lawn, Old Youghal Road, Cork {16 No. Houses, (1-7 on Old Youghal Road, 8-16 off Cahergal Lawn)}, be taken in charge forthwith".

The report of the Assistant City Manager stated that, Deerpark Estate, Barrack St., Tramore Rd., Green St. and Mount Sion Rd. will be considered for inclusion in the 2010 Resurfacing Programme.

# 5.5 <u>CCTV IN BLARNEY STREET</u>

An Chomhairle considered and approved the report of Assistant City Manager, dated 4th February, 2010, on the following motion which was referred to the Committee by An Chomhairle.

'That CCTV would be installed in Blarney Street to help tackle anti-social behaviour.'

(Proposer: Cllr. K. O'Flynn 09/220)

The report of the Assistant City Manager stated that, the installation of the CCTV system in the City Centre was carried out by contractors on behalf of the Department of Justice in conjunction with the Garda Siochána. The system is managed and operated solely by the Gardaí. The only involvement Cork City Council had was to allow the contractor to use where available, traffic ducting to carry the CCTV cable.

The installation of a CCTV system for Blarney Street is therefore primarily the concern of the Gardaí. The Gardaí will be informed of the request in the above motion and if it is decided to proceed with the installation of CCTV in Blarney Street, the City Council will give any assistance possible.

# 5.6 TRAFFIC FLOW AT JUNCTION AT FRIAR STREET/ EVERGREEN STREET/ DOUGLAS STREET AND INDUSTRY STREET

An Chomhairle considered and approved the report of Assistant City Manager, dated 4th February, 2010, on the following motion which was referred to the Committee by An Chomhairle.

'That Cork City Council reviews traffic flow and safety precautions at the spaghetti junction at Friar Street/ Evergreen Street/ Douglas Street/ Industry Street and introduces any required features including road markings and/ or electronic roadside signage, mindful of increased one-way traffic travelling west along Evergreen Street and the implications that this is having on the junction.'

(Proposer: Cllr. M. Finn 09/434)

The report of the Assistant City Manager stated that, the junction of at Friar Street/ Evergreen Street/ Abbey Street (Douglas Street)/ Industry Street is being examined in the context of the South Parish Area Action Plan. A particular road layout format for the junction is proposed for the public consultation stage of the Area Action Plan.

Depending on the responses from the general public and various stakeholders, a final layout will be designed subject to road safety considerations, etc. The implementation of the new layout will be put forward for consideration to be included in the roads programme.

# 5.7 **ROAD OPENING LICENCE**

An Chomhairle considered and approved the report of Assistant City Manager, dated 4th February, 2010, on the following motion which was referred to the Committee by An Chomhairle.

'That Cork City Council ensure that all utilities that apply for a Road Opening Licence be obliged to contact other users with a view to informing them of the intended work.'

(Proposer: Cllr. S. Martin 09/430)

The report of the Assistant City Manager stated that, Cork City Council operates a Roadworks Control System for the purpose of authorising road cuttings. The Roads & Transportation Directorate circulates weekly a list of all works which have been granted a licence to the following:

#### 5.8 **ANTI-SOCIAL BEHAVIOUR**

An Chomhairle considered and approved the report of Assistant City Manager, dated 4th February, 2010 on the following motion which was sent back by Council to the Committee.

'That Cork City Council prepare a report for Council on the alternative options which can be pursued to successfully eliminate anti-social behaviour with options other than total closure being looked at including the use of gates during particular times with general agreement of residents and Gardai where abolition of public rights of way cannot be agreed.'

(Proposer: Cllr. T. Brosnan 09/400)

The report of the Assistant City Manager stated that, S73 of the Roads Act 1993 states that "It shall be a function of a local authority to protect the right of the public to use public rights of way in its administrative area."

The legal option that Local Authorities have with regard to public rights of way is covered by Section 73 of the Roads Act 1993 which covers the extinguishment of public rights of way. This section outlines the statutory process to be undertaken to effect the proposed extinguishment of a public right of way.

The elimination of anti-social behaviour itself is a public order matter for the Garda Siochána. Laneway closures may assist in reducing anti-social behaviour at the specific location in question but in many cases only result in the problem being moved to another location.

Where extinguishments of public rights of way have been enacted, the laneways are permanently closed off from use by the general public.

An Chomhairle considered and approved the report of the Director of Services, Housing & Community dated 2<sup>nd</sup> December, 2009 on the following motion referred to the Committee by An Chomhairle:-

'That Cork City Council mandates the housing department to provide Councillors with a monthly update, in writing, on the status of housing applications on whose behalf they have made representations.'

(Proposer: Cllr. T. Gould 09/360)

The report of the Director of Services stated that the information requested is not currently available in the format outlined and unfortunately there are no resources available to compile it in this manner. Applicants can enquire as to the status of their application at any time, either by calling to the public counter, which is open Monday to Friday from 9.00 a.m. to 4.00 p.m. or by contacting the office by telephone.

The report also stated that Members are provided with a report of all allocations made and refusals on a monthly basis.

# 6.5 ACCESS TO LANEWAY NEXT TO THE LOUGH COMMUNITY CENTRE

An Chomhairle considered and approved the report of the Director of Services, Housing & Community dated 4<sup>th</sup> February, 2010 on the following motion referred to the Committee by An Chomhairle.

'That Cork City Council open the access to the laneway next to the Lough Community Centre. The lane has become overgrown and there are problems with vermin in the area. A recent inspection by the Fire Officer also reported that as one of the community centre's fire exits opens onto the laneway, work will need to be done to free it up. The Lough Community Association are willing to make the laneway into a community garden.'

(Proposer: Cllr. E. O'Halloran 09/421)

The report of the Director of Services stated that as set out in the Part 8 report to Council, dated 1<sup>st</sup> November 2004, in respect of the construction of social housing units at the 'Dyefield', Deerpark, Friars Walk, the laneway adjoining the Lough Community Association Centre, was not included within the development site and the control over the area (i.e. laneway) was to be given to the Community Association.

Consideration on the form of 'disposal' has been complicated by submissions from a third party outlining their right of interest of access to the laneway, since the Part 8 Report was approved by Council.

The report also stated that although our discussions on the matter were at an advanced stage, in the past couple of months, in the course of finalising the details of disposal for the Property Section's report to Council, the third party met with a City Council Housing official and advised that he would be making a further written submission to the City Council's Law Agent. The Housing Directorate deferred the matter pending receipt of the written submission. However, as the submission has not been received in the intervening 2 months, it is proposed to forward the proposals for the disposal to the Property Department to progress, over the coming weeks. In response to the issues

raised in respect of the laneway being overgrown and problems with vermin, the Housing Directorate will inspect the site and attend to the matter.

The pay cut and the current embargo on recruitment mean that Cork City Council workers are currently working harder for less."
