The Minutes of Ordinary Meeting of An Chomhairle held on 13th October 2008 were considered and approved.

3. **SUSPENSION OF STANDING ORDERS**

On the proposal of Comhairleoir J. Corr seconded by Comhairleoir T. Brosnan, An Chomhairle agreed to suspend Standing Orders to discuss proposed reduction in Local Government funding to Cork City Council in 2009, at the finish of the business of the meeting.

4. **QUESTIONS**

4.1. **ASHLEIGH GARDENS, SKEHARD**

In response to the following question submitted by Comhairleoir D. Counihan, a written reply was circulated as outlined below:

When can it be anticipated that the traffic calming measures agreed some time ago for Ashleigh Gardens, Skehard, Blackrock, can be put in place?

Ashleigh Gardens, Skehard, Blackrock was selected to be included in the 2005 traffic calming schemes. However during the public consultation process, a majority of the local residents from Ashleigh gardens signed a petition strongly objecting to any form of traffic calming “structures” on the roadway.

Accordingly, the project did not go ahead. The issue was again discussed at the ward meeting earlier this year and no decision was made on the matter. The issue can be reconsidered at the next ward meeting

4.2 **CURRAGH ROAD/ 7 & 9 MT. SION ROAD**

In response to the following question submitted by Comhairleoir S. Martin, a written reply was circulated as outlined below:

a) What was the result of the recent investigations by City Council into the problems of flooding on the Curragh Road, Turners Cross?

b) Why has it taken so long to fix the leak between 7 & 9 Mt. Sion Road adjacent to Townsend Place?

a) Debris, believed to have entered the sewer system from construction works in the vicinity had built up and partially blocked the sewers, resulting in flooding during a period of heavy rain on the evening of 8th September 2008. These sewers had been cleaned a number of months previous to this incident, however debris including concrete, grit and stones were removed from the sewers by the Drainage Section after the flooding. In addition to the sewer cleaning works carried out, it is the intention of the Roads Dept. to place extra gullies in this area.

b) The leak on Mont Sion Road was reported on a Friday and was not deemed to be an urgent priority requiring a crew to be brought in at the weekend.

Following investigation by a water inspector it was found to be leaking hydrant. It was referred to the yard for repair where the works were scheduled and carried out.

4.3 **COMMUNITY CENTRE – KNOCKNAHEENY & GURRANABRAHER**

In response to the following question submitted by Comhairleoir M. O' Connell, a written reply was circulated as outlined below:

Can the Manager tell me when does he expect work to be completed on both the Community Centre in both Knocknaheeny and Gurrabraher?

- b) What groups have been allocated space in both centres so far?
- c) Will Cork City Council be appointing a manager to run both centres?
- d) Will both centres have an elected Board of Management?
- e) Will there be provision for local Councillors in the area to be appointed on to the Boards?

Work is completed on the Gurrabraher Community Building apart from minor remedial issues.

Work is expected to be completed on the Knocknaheeny Community Building by end December 2008.

- a) Five groups have been allocated space in the Knocknaheeny Building:

- We The People
- The NICHE project
- The Local Employment Service
- The Citizens Information Service
- The Society of St Vincent de Paul

Three groups have been allocated space in the Gurrabraher building:

- The Gurrabraher / Churchfield Youth Development project
- The Churchfield Community Development project
- The Health Service Executive -a range of services

A large portion of the building will be available for general community use and discussions are ongoing regarding further lettings.

- b) A Manager has been appointed to run the Gurrabraher building on the basis of external funding secured for a three year period. Management arrangements for the Knocknaheeny building are under discussion.
- c) It is intended that both buildings will have representative Boards of Management nominated by users and the Community .the details will be discussed and agreed with the users and the local elected members.

- d) Discussions on representation will take place with local members and provision will be made for approval by Council.

4.4 **CONSULTATION PROCESS – KNOCKNAHEENY MASTERPLAN**

In response to the following question submitted by Comhairleoir T. Fitzgerald, a written reply was circulated as outlined below:

To ask the Manager to review and update the consultation process under the Knocknaheeny Masterplan, with a particular emphasis in the residential areas, in the interest of proper Community Health Planning and, put in place –

- a.) A strategic plan whereby consultation with the local residents will be conducted well in advance of further developments.
- b.) A plan and overview in relation to Block EFGH, how it will be constructed, digital images of new developments and a time frame for each block as it is developed.
- c.) A report on the current status of the development of Dunnycove Crescent and Kilmore Road.
- d.) Concrete proposed plans for Dunmore Gardens and Kilmore Road.
- e.) What plans, if any, has Council for Kilmore Road stretching from John F. Connelly Road northwards to Nash’s Boreen, including the Watertower.

- (a) The City Council are obliged to advertise and take submissions into account before proceeding with any development.
- (b) As agreed at the Housing Committee on 13th October, this will be provided to Members in due course.
- (c) The decanting of Dunnycove Crescent and Kilmore Road Lower is currently on-going. 20 no. residents out of 23 no. have been relocated.
- (d) Noted.
- (e) Once vacant possession of Dunnycove Crescent/Kilmore Road Lower has been obtained, a further report will issue to Members on proposals for the area.

4.5 **TRAFFIC CALMING – FAIRFIELD ROAD, HOLLYMOUNT ESTATE, ASCENSION HEIGHTS**

In response to the following question submitted by Comhairleoir D. McCarthy, a written reply was circulated as outlined below:

As traffic calming measures for Fairfield Road, Hollymount Estate and Ascension Heights have been included in the city budget, would the Manager please inform me as to when these works will commence?

The three areas mentioned in the question were selected earlier this year to be included in the list of 2008 Traffic Calming Schemes. Appropriate traffic calming

measures are currently being designed and when completed, the proposals will be brought forward to the public consultation stage.

The public consultation stage may result in some design changes and taking into account the time periods involved in the various stages, i.e. design, public consultation, adjustments, tendering of contract, selection of contractor, etc. it will be next year before work will actually start on the ground.

4.6 **ATKINS HALL**

In response to the following question submitted by Comhairleoir C. Clancy, a written reply was circulated as outlined below:

- a) What is the update position on Cork City Council acquiring Atkins Hall for social housing?
- b) Have any monies been paid over to the owners/developer of Atkins Hall?

- a) Cork City Council Housing & Community Directorate have contracted to purchase 96 units (76 no Social units & 20 no. RAS units) from Lance Investments at Atkins Hall, Lee Road.

In July 2006 Cork City Council appointed Mott Mc Donald Pettit to snag the relevant apartments and to follow up with the developers on the completion of the units to the satisfaction of Cork City Council, prior to their handover. When the development achieves the necessary standards to the satisfaction of Cork City Council, the acquisition of the units will be completed.

- b) The contract price is €25,365,000 and €2,536,500 was paid by way of deposit on the execution of the agreement.

4.7 **TRAFFIC MANAGEMENT PLANS – UCC AREA**

In response to the following question submitted by Comhairleoir J. Buttimer, a written reply was circulated as outlined below:

Can the City Manager indicate what traffic management plans are in place for the area adjacent to UCC and what specific plans are in place to minimize non-residential traffic in the area, with specific reference to the area between Glasheen Road, Magazine Road, College Road and Horgan Buildings and if he will make a statement on the issue?

There are several roads linking Glasheen Road, Magazine Road and College Road, i.e. Dorgan's Road, Highfield Avenue, Coolgarten Park, Highfield West, Glasheen Park/ Kilcrea Park, St. Claire's Avenue, School Avenue/Liam Lawn and St. Francis Avenue.

Most of these roads carry local traffic to the residential areas and the local institutions such as UCC and Bons Secours Hospital, while some like Dorgan's Road and Highfield Avenue carry trips with longer journeys. The roads in this location function in a very similar fashion to most roads in the city urban road network. It should be noted that these roads also have pay parking controls in order to deter non residential parking. While traffic calming will reduce any traffic speeding in the area, the elimination of 'through traffic' can only be done by the creation of cul-de-sacs on the roadways.

There is a proposal to construct a cul-de-sac in Horgan's Buildings in order to eliminate the through traffic in what is a very tight residential area, however the cost involved is in excess of €85,000 and to date, no funding has been sourced for this work.

4.8 **PARKING FEE – FREE PARKING FOR EMPLOYEES**

In response to the following question submitted by Comhairleoir T. Brosnan, a written reply was circulated as outlined below:

Can the Manager please confirm if this Council has the authority to impose a per diem parking fee on those employees currently enjoying free parking and can he also confirm the revenue that the Council would raise for a 5 Euro per day charge?

The City Council has always provided car parking facilities for a percentage of its staff and members of the City Council.

Were the Council to introduce charges for these facilities, it would have to negotiate such arrangements with staff representatives and members of City Council.

In the centre area there are (120 + 140) 260 car parking for use by Councillors and staff.

The Government has recently announced a scheme in relation to car parking facilities for employees in the major cities. I am awaiting details of this scheme.

5. **GUS HEALY POOL - DOUGLAS**

An Chomhairle noted the report of the City Manager dated 28th October 2008, on the Gus Healy Swimming Pool, Douglas and further agreed that matters arising from the report be brought to the next meeting of Recreation, Amenity & Culture Functional Committee for consideration.

6. **CORK OPERA HOUSE REFURBISHMENT PROGRAMME**

Comhairleoirí D. Wallace, T. Shannon, J. Corr, M. O'Connell, M. Quill, S. Martin declared an interest in this matter.

An Chomhairle approved the report of the City Manager dated 28th October 2008 on Cork Opera House Refurbishment Programme, and on the proposal of Comhairleoir T. Brosnan, seconded by Comhairleoir J. Kelleher agreed to adopt the following resolution:

“RESOLVED THAT

that Cork City Council provide financial capital of €250,000 to the Board of Cork Opera House to help fund refurbishment works.”

7. **MOTIONS REFERRED FROM MEETING OF AN CHOMHAIRLE HELD ON 13th OCTOBER 2008**

An Chomhairle approved the following three motions.

7.1 **COMMUTER STATION AT TIVOLI**

‘That Cork City Council calls on Irish Rail to re-open the commuter station at Tivoli to facilitate residents of Mayfield/ Montenotte and surrounding areas and also tourists at local Hotels and Guest Houses. The City Council should assist financially from the accumulated development charges levied on new housing in the area, part of which was specifically levied because of proximity to the railway line and that Council officials would identify that portion of total development charges collected to date when reporting on this motion.’

7.2 **REPOSSESSION OF LOCAL AUTHORITY HOUSES**

‘That Cork City Council call on the Government to include in the (Housing Miscellaneous)(Provisions Bill) 2008, legislation that would enable Local Authorities to fast track the repossession of Local Authority Houses from tenants who have been convicted of dealing in, the manufacturing, production, preparation, importation, sale, supply, possession for the purpose of sale or supply, or distribution of a controlled drug (within the meaning of the misuse of Drugs Act 1977 and 1984), which has resulted in major anti-social behaviour problems in many estates throughout the City where people are now openly dealing drugs from their homes and where recent figures announced by the Garda show a massive increase in the availability of drugs throughout the City and County and in particular the easy availability of heroin.’

7.3 **PROBATIONARY PERIOD OF 12 MONTHS TO PEOPLE ON THE HOUSING LIST**

‘That Cork City Council call on the Government to include in the (Housing Miscellaneous) (Provision Bill) 2008, legislation that would enable Local Authorities to include in their Scheme of Letting Priorities a probationary period of tenancy of twelve months to people on the Housing List after which probationary tenants would be reassessed as to their suitability of being given permanent tenancy of a Local Authority Property.’

8. **ROADS & TRANSPORTATION FUNCTIONAL COMMITTEE – 13th OCTOBER 2008**

8.1 **ROADWORKS PROGRAMME**

An Chomhairle approved the report of the Assistant City Manager, dated 9th October, 2008, on the progress of ongoing Roadworks Programme for month ended September, 2008.

8.2 **TAKING IN CHARGE – “THE STEEPLES”, LOWER MAYFIELD, CORK (8 NO. HOUSES (THE STEEPLES) INCLUDING ACCESS TO PAROCHIAL HOUSE, MAYFIELD CHURCH AND NO. 1 PRESBYTERY HOUSE).**

An Chomhairle approved the report of the Assistant City Manager dated 9th October 2008 regarding development at “The Steeples”, Lower Mayfield, Cork. On the proposal of Comhairleoir J. Corr, seconded by Comhairleoir S. Martin, An Chomhairle further adopted the following resolution.

“NOW COUNCIL HEREBY RESOLVES THAT

Pursuant to the provisions of Section 180 of the Planning and Development Act 2000 in circumstances where Council is being asked to consider the proposed taking in charge of a residential development and the provisions of Section 11 (1) of the Roads Act 1993, that the roads at “The Steeples”, Lower Mayfield, Cork (8 No. Houses {The Steeples} including access to Parochial House, Mayfield Church and No. 1 Presbytery House), be taken in charge.”

8.6 **REPORT ON PARKING MANAGEMENT BUSINESS PLAN**

An Chomhairle approved the report of the Assistant City Manager dated 13th October 2008 regarding the Parking Management Business Plan.

The report of the Assistant City Manager stated that

○ **Parking in the Mobility Context**

Efficient transport provision within Cork City is vital to the economic vitality and quality of life of our citizens. Parking policy and parking management play a very important role in urban mobility, both in enhancing accessibility and in combating urban congestion. In modern mobility management, parking demand management is one of the strongest management tools available to Local Authorities. Parking demand management must be viewed within the overall context of traffic management and the accessibility needs of the people and businesses. Within the city, effective control of parking is essential in ensuring accessibility to workplaces, businesses and areas of leisure activity.

Effective parking regimes at the macro level in terms of supporting the economic development of a region are required, and at the micro level in terms of the impacts of car trip generation associated with land use, air and also noise quality.

Cork City Council has to deal with a number of conflicting expectations in managing the parking supply and demand equation, e.g. political and economic considerations, revenue generation and meeting the needs of the common good may sometimes conflict with individual needs along the way. A balanced flexible management approach will respond to changes in the economic, social and cultural conditions in our city.

○ **Parking Contribution**

The Parking Management Section is one of three business units within the Traffic Division of the Roads and Transportation Directorate in Cork City Council. It reports to the Council through the Roads & Transportation Functional Committee on operational matters and also to the Roads & Transportation Strategic Policy Committee on matters relating to transport policy and planning issues. Parking regimes that best fit the collective aspirations and ambitions of the key stakeholders will make the best contribution.

The Transportation Division deals with the significant challenge of balancing the requirements of each road user for space. It has an income approaching €11.5m with costs of over €6m, the remaining surplus being used to fund other transportation related projects including road maintenance, public lighting, traffic calming, road lining and signage, etc.

Through the development of the Local Transport Plan, we have clearly identified that our Strategic Objective is to:

“Manage the demand for on/off street parking to achieve optimal balance between long and short term parking to facilitate living, business activity and leisure activity in the city”.

The will be delivered by:

a) Adopting time based parking zones to maximise the turnover of short term car parking spaces.

The required tactical strategies to deliver this are

- Actively manage the occupancy of parking spaces;
- Provide user friendly information at car parking spaces;
- Implement a differentiated pricing policy for different types of car parking spaces;
- Provide multiple payment methods for car parking spaces;
- Raise compliance with parking regulations.

b) Introducing and encouraging smarter choices to reduce congestion and improve the living environment.

The required tactical strategies to deliver this are

- Ensure balance between supply and demand for different types of car parking spaces;

- Work in close cooperation with external stakeholders to contribute towards delivering a modal shift from the private car.
- Each tactical strategy will be executed by the integrations of activities and developing standard operating procedures.

We will ensure that 'the customer gets for what the customer pays'. Our value-proposition will assist in development of our marketing strategy, and will help us to target particular market segments.

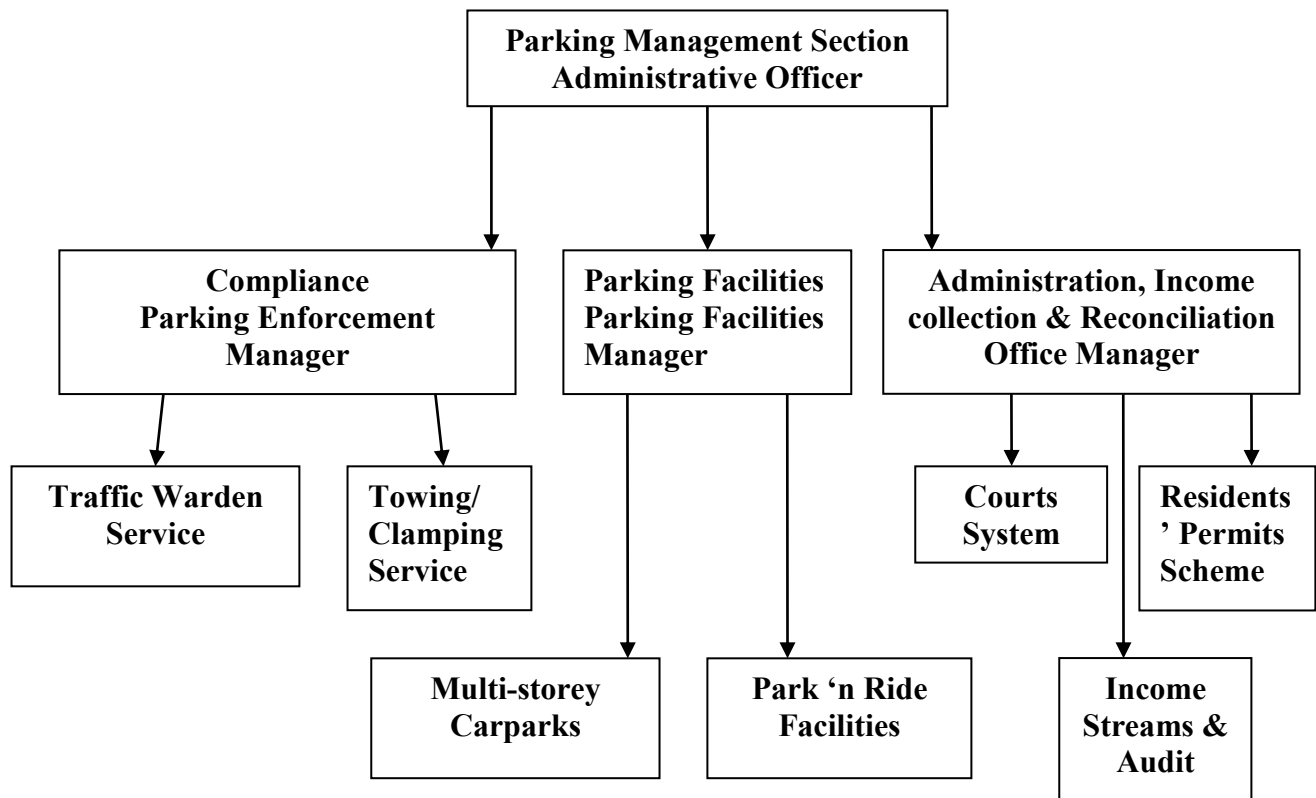

8.7 **FRIARS WALK, TORY TOP ROAD – 2008 ROAD RESURFACING PROGRAMME**

An Chomhairle approved the report of the Assistant City Manager, dated 9th October, 2008, on the following motion which was referred to the Committee by An Chomhairle.

‘That Cork City Council include Friars Walk, Tory Top Road junction in the 2008 Road Resurfacing Programme.

(Proposer: Cllr. S. Martin 07/187)

The report of the Assistant City Manager stated that the Report stated that, the Friars Walk/Tory Top Road junction is not included in the 2008 Road Resurfacing Programme. This junction will be considered for inclusion in next year’s programme. In the meantime, any repairs considered necessary will be carried out.

8.8 **TRAFFIC CALMING – FR. DOMINIC ROAD**

An Chomhairle approved the report of the Assistant City Manager, dated 9th October, 2008, on the following motion which was referred to the Committee by An Chomhairle.

‘That traffic calming be installed in Father Dominic Road, between 8 and 11 on the sweep of the bend and that the footpath outside 2 to 8 be immediately resurfaced.’

(Proposer: Cllr. S. Martin 07/189)

The report of the Assistant City Manager stated that Father Dominic Road is already on the list of areas, where a request for traffic calming has been received. Surveys will be carried out in the vicinity of 8 - 11 Fr. Dominic Road in order to identify any possible mitigation measures that could be provided there.

Identified appropriate traffic calming measures will be put forward for consideration to be included in the Roads Programme.

The footpath outside 2 to 8 Fr. Dominic Road has been recently resurfaced as part of our 2008 Footpath Overlay Programme.

8.9 **LAKE LAWN, WELL ROAD BE SURVEYED**

An Chomhairle approved the report of the Assistant City Manager, dated 9th October, 2008, on the following motion which was referred to the Committee by An Chomhairle.

‘That Lake Lawn, Well Road be surveyed with a view to the Road Carriageway being resurfaced in the two Cul de Sac where road subsidence is a major problem. This work should be included in the 2009 Programme.’

(Proposer: Cllr. T. Shannon 08/247)

The report of the Assistant City Manager stated that Lake Lawn, Well Road will be considered for inclusion in the 2009 Road Resurfacing Programme.

8.10 **BELMONT PARK, BALLINLOUGH INCLUDED IN 2009 ROAD RESURFACING PROGRAMME**

An Chomhairle approved the report of the Assistant City Manager, dated 9th October, 2008, on the following motion which was referred to the Committee by An Chomhairle.

‘That Belmont Park, Ballinlough be included in the 2009 Road Resurfacing Programme as the road carriageway is in a very poor state.’

(Proposer: Cllr. T. Shannon 08/248)

The report of the Assistant City Manager stated that Belmont Park, Ballinlough will be considered for inclusion in the 2009 Road Resurfacing Programme.

8.11 **DOUBLE YELLOW LINES BALLINLOUGH ROAD**

An Chomhairle approved the report of the Assistant City Manager, dated 9th October, 2008, on the following motion which was referred to the Committee by An Chomhairle.

‘That Cork City Council would install double yellow lines outside the entrances to homes adjacent to J.J. O’Driscoll’s shop on the Ballinlough Road, in an effort to reduce the amount of illegal parking in the area.’

(Proposer: Cllr. L. McGonigle 08/279)

The report of the Assistant City Manager stated that it is illegal to park outside a vehicular entrance without the consent of the owner of the premises concerned and double yellow lines are not required. The legal spaces for parking adjacent to J.J.O’Driscoll’s shop were marked and boxed out in the recent past, in an attempt to reduce the incidence of driveways of private houses being blocked and these markings will be refreshed.

However, the area will be visited with the Gardaí and if it is deemed appropriate, double yellow lines will be provided outside a limited number of driveways close to J.J. O’Driscoll’s shop on Ballinlough Road.

8.12 **PEDESTRIAN BARRIER ON THE BLARNEY ROAD**

An Chomhairle approved the report of the Assistant City Manager, dated 9th October, 2008, on the following motion which was referred to the Committee by An Chomhairle.

‘That Cork City Council replace the pedestrian barrier at the foot of the steps at hillcrest Estate on the Blarney Road in the interest of public safety.’

(Proposer: Cllr. T. Fitzgerald 08/285)

The report of the Assistant City Manager stated that this barrier will be replaced in the coming months.

8.13 **CLOSE THE ALLEYWAY BETWEEN VILLE VIEW TERRACE AND STRAWBERRY HILL**

An Chomhairle approved the report of the Assistant City Manager, dated 9th October, 2008, on the following motion which was referred to the Committee by An Chomhairle.

‘That Cork City Council would close off the alleyway between Ville View Terrace, Strawberry Hill and Shanakiel Road following requests from residents. This alleyway is not in use and is causing anti-social behaviour.’

(Proposer: Cllr. M. O’Connell 08/295)

The report of the Assistant City Manager stated that the 2008 programme for the Closure of Pedestrian Laneways was approved by Ward Members at a meeting in early 2008. The closure of the pedestrian laneway at Ville View Terrace, Strawberry Hill and Shanakiel Road, is not included in the list of prioritised locations. Ville View Terrace will be added to the current list of requested laneway closures and will be available for prioritisation subject to future funding.

8.14 **2009 ROADS PROGRAMME – KILCOLMAN LAWN**

An Chomhairle approved the report of the Assistant City Manager, dated 9th October, 2008, on the following motion which was referred to the Committee by An Chomhairle.

‘That Cork City Council would include Kilcolman Lawn, South Douglas Road for inclusion of the 2009 Roads Programme given the poor state of the carriageway.’

(Proposer: Cllr. L. McGonigle 08/305)

The report of the Assistant City Manager stated that Kilcolman Lawn, South Douglas Road will be considered for inclusion in the 2009 Road Resurfacing Programme.

8.15 **TRAFFIC CALMING AT GLENGARIFF ROAD**

An Chomhairle approved the report of the Assistant City Manager, dated 9th October, 2008, on the following motion which was referred to the Committee by An Chomhairle.

‘That Cork City Council put in place traffic calming measures in Glengariff Road, Fairhill.’

(Proposer: Cllr T. Fitzgerald 08/306)

The report of the Assistant City Manager stated that Glengariff Road, Fairhill will be added to the list of areas, where a request for traffic calming has been received. Traffic volume and speed surveys will be carried out to determine the extent of the problems in order to identify any possible mitigation measures that could be provided there. Identified appropriate traffic calming measures will be put forward for consideration to be included in the Roads Programme.

8.16 **COBBLESTONE ROAD SURFACE ON BEASLEY STREET**

An Chomhairle approved the report of the Assistant City Manager, dated 9th October, 2008, on the following motion which was referred to the Committee by An Chomhairle.

‘That the old cobblestone road surface on Beasley Street (off Oliver Plunkett St.) be re-instated as a matter of urgency.’

(Proposer: Cllr. D. Murphy 08/308)

The report of the Assistant City Manager stated that we will prepare a street improvement scheme for Beasley Street and if possible incorporate a cobblestone surface subject to availability of the materials and compliant with safety requirements. Implementation of the scheme will be subject to acquiring the necessary funding.

8.17 **FOOTPATHS ON LOWER CONNOLLY ROAD**

An Chomhairle approved the report of the Assistant City Manager, dated 9th October, 2008, on the following motion which was referred to the Committee by An Chomhairle.

‘That the footpaths on Lower Connolly Road be included in the 2009 Renewal Programme.’

(Proposer: Cllr. T. O’Driscoll 08/311)

The report of the Assistant City Manager stated that the footpaths on Lower Connolly Road be considered for inclusion in the 2009 Footpath Renewal Programme.

8.18 **TRAFFIC CALMING MEASURES AT SILVERSPRINGS COURT, TIVOLI**

An Chomhairle approved the report of the Assistant City Manager, dated 9th October, 2008, on the following motion which was referred to the Committee by An Chomhairle.

‘That Cork City Council would put traffic calming measures in place in Silversprings Court, Tivoli in consultation with the local residents and the Silversprings Court Residents Association in order to ensure safety for children and pedestrians and local drivers.’

(Proposer: Cllr. T. Brosnan 08/314)

The report of the Assistant City Manager stated that Silversprings Court, Tivoli is already on the list of areas, where a request for traffic calming has been received. Traffic volume and speed surveys are due to be carried out to determine the extent of the problems in order to identify any possible mitigation measures that could be provided there.

Identified appropriate traffic calming measures will be put forward for consideration to be included in the Roads Programme.

8.19 **UPGRADE LIGHTING ON SILVERHEIGHTS ROAD**

An Chomhairle approved the report of the Assistant City Manager, dated 9th October, 2008, on the following motion which was referred to the Committee by An Chomhairle.

‘That Cork City Council would seriously upgrade public lighting on Silverheights Road and Boherboy Road both of which are part of the No. 8 Bus route and have high pedestrian and traffic use.’

(Proposer: Cllr. T. Brosnan 08/315)

The report of the Assistant City Manager stated that the public lighting on Silversprings Road and Boherboy Road will be examined and assessed for necessary measures to bring the lighting quality in the area to modern acceptable standards. Any identified measures will be put forward for consideration to be included in next year’s roads programme or alternatively will be brought to the attention of the local Ward meeting for possible funding from Ward funds. Possible funding from the Green Routes Project will also be considered.

8.20 **CURBSTONES SURROUNDING THE GREEN AREA IN PARKVIEW**

An Chomhairle approved the report of the Assistant City Manager, dated 9th October, 2008, on the following motion which was referred to the Committee by An Chomhairle.

‘That the City Council carry out a costing to replace the curbstones surrounding the green area in Parkview, Parklands.’

(Proposer: Cllr. J. O’Brien 08/319)

The report of the Assistant City Manager stated that the kerbs in this location have been damaged by cars parking on the edge of the green area. This would indicate that there is a shortage of available car parking spaces in this estate. Roads Maintenance will consult with the residents as to whether to reinstate the kerbs in the existing position or to possibly provide additional car parking spaces. A costing of the options will then be undertaken.

8.21 **HANDRAIL FOR STEPS TO LOWER BARRETTS TERRACE**

An Chomhairle approved the report of the Assistant City Manager, dated 9th October, 2008, on the following motion which was referred to the Committee by An Chomhairle.

‘That a handrail be located at both sides of the steps to Lower Barretts Terrace from Lower Barretts Buildings in view of the fact that there are a lot of elderly people in that area who find the steps very dangerous and furthermore, that a public light be located at the end of the steps as they are insufficiently lit.’

(Proposer: Cllr. P. Gosch 08/320)

The report of the Assistant City Manager stated that Roads Maintenance will seek quotations for the provision of hand rails at this location and carry out the work in the near future.

The public lighting at the steps to Lower Barrett’s Terrace from Lower Barrett’s Buildings will be examined and assessed for necessary measures to bring the lighting quality in the area to modern acceptable standards. Any identified measures will be put forward for consideration to be included in next year’s roads programme or alternatively will be brought to the attention of the local Ward meeting for possible funding from Ward funds.

8.22 **FOOTPATH ON GARRANE LANE**

An Chomhairle approved the report of the Assistant City Manager, dated 9th October, 2008, on the following motion which was referred to the Committee by An Chomhairle.

‘That the footpaths on Garrane Lane (i.e. from the Bishopstown Road to Woodhaven) and Laurel Grove in Bishopstown would be surveyed so as to replace and repair the surface of the footpath and to raise the height of the footpaths above the road surface level.’

(Proposer: Cllr. J. Buttimer 08/321)

The report of the Assistant City Manager stated that we will inspect the footpaths at Garrane Lane and Laurel Grove and they will be considered for inclusion in the 2009 Footpath Renewal Programme. In the meantime, we will carry out any repairs considered necessary.

8.23 **TRAFFIC CALMING MEASURES ON FARRANLEA ROAD**

An Chomhairle approved the report of the Assistant City Manager, dated 9th October, 2008, on the following motion which was referred to the Committee by An Chomhairle.

‘That additional traffic calming measures be introduced on the section of roadway at Farranlea Road from the junction at Farranlea Grove to Farranlea Park.’

(Proposer: Cllr. J. Buttimer 08/322)

The report of the Assistant City Manager stated that the section of roadway at Farranlea Road from the junction at Farranlea Grove to Farranlea Park will be examined and assessed for additional traffic calming measures, and any identified measures will be put forward for consideration to be included in next year’s roads programme.

8.24 **REPAIR OF WALL OUTSIDE 29 LIMWOOD GROVE ONSLOW GARDENS**

An Chomhairle approved the report of the Assistant City Manager, dated 9th October, 2008, on the following motion which was referred to the Committee by An Chomhairle.

‘Given the unstable and dangerous condition of the wall outside 29 Limewood Grove, Onslow Gardens, I propose that Cork City Council would carry out repairs to same as a matter of urgency’.

(Proposer: Cllr. D. McCarthy 08/270)

The report of the Assistant City Manager stated that remedial works will take place at this location in the coming weeks.

8.25 **ONE WAY TRAFFIC – EVERGREEN STREET**

An Chomhairle approved the report of the Assistant City Manager, dated 13th October, 2008, on the following motion which was referred to the Committee by An Chomhairle.

‘That City Council look at a one way Traffic Management system to be installed to improve traffic flow on Evergreen St., Tower St. and Friar St.’

(Proposer: Cllr. S. Martin 07/158)

The report of the Assistant City Manager stated that introducing one-way traffic systems and where possible to revert existing one-way systems to two-way. One-way traffic flows do not generally improve road safety, particularly for pedestrians, because of:

- (a) Increased traffic speeds and
- (b) Increased volumes of traffic in the direction of flow.

There are other disadvantages such as:

- Reduction in local accessibility for traders and residents, i.e. local journeys in a particular direction can be made more difficult
- Increased volumes of traffic in the opposite direction in a parallel ‘twined’ road.
- One-way system may not suit service vehicles (refuse collection, deliveries etc.)
However, a meeting was held between public representatives, Gardaí and City Hall officials on Friday 10th October 2008 to discuss a possible one-way system in the Quaker Road/Tower Street/Evergreen Street area. It was decided to install a traffic management pilot scheme where:
 - Tower Street between junctions with Friar Street and Evergreen Street will be made one-way eastbound and
 - Evergreen Street between junctions with Tower Street and Friar’s Street will be made one-way northbound.

A local ‘traffic gyratory’ will thus be formed, and the trial period will be for six months after which time, the traffic management system will be reviewed and either modified or made permanent.

A public consultation process under the Roads Traffic Act 1994 will now begin to give a legal basis for the traffic changes.

9. **HOUSING & COMMUNITY STRATEGIC POLICY COMMITTEE – 19th SEPTEMBER 2008**

9.1 **QUARTERLY REPORT**

An Chomhairle approved the report of the Director of Services on Housing for the quarter ended 30th June, 2008.

9.2 **HOUSING NEEDS ASSESSMENT**

An Chomhairle approved the report of the Director of Services dated 11th September, 2008 on the 2008 Housing Needs Assessment.

9.3 **OPEN AND TRANSPARENT HOUSING LIST**

An Chomhairle agreed to defer decision on the report of the Director of Services dated 11th September, 2008 on the following motion to the next meeting of An Chomhairle:-

‘That Cork City Council will introduce an open and transparent Housing List. Housing List is 'live'. Applicants can view their position on the Housing List via the website using their individual reference and PIN number which is issued to the applicant on approval of their application. Alternatively, applicants can contact Allocations Section by phone or call to Customer Care.

Applicants can view their position and also view overall priority which may be given to applicants that satisfy the following criteria. Priority will be granted in the order shown and subject to the availability of suitable accommodation at the time:

(i) Families or persons living in dangerous premises on whom a requisition under Section 3 (9) of the Local Government (Sanitary Services) Act, 1964 has been served.

(ii) Displacement (resulting from acts of the Local Authority).

(iii) Families or persons rendered homeless through no fault of their own. A person shall be regarded by a housing authority as being homeless for the purposes of this Act if:

(a) there is no accommodation available which, in the opinion of the authority, he/she, together with any other person who normally resides with him/her or who might reasonably be expected to reside with him/her, can reasonably occupy or remain in occupation of, or

(b) he/she is living in a hospital, County home, night shelter, or other such institution and is so living because he/she has no accommodation of the kind referred to in paragraph (a), and he/she, in the opinion of the authority, unable to provide accommodation from his/her own resources.

- (iv) Families or persons evicted through no fault of their own on foot of a Court Order who are not in a financial position to provide their own housing.
- (v) Exceptional medical/compassionate grounds.
- (i) Persons aged 55 or over

Applicants with overall priority will be given priority over other applicants in the letting of available accommodation in the order of priority indicated above.

Where priority for housing accommodation is claimed on grounds consisting of or including medical grounds, regard shall be had to the report of the Council's Medical Advisers. The allocation of emergency accommodation is administered by the Homeless Persons Unit in conjunction with Cork City Council.

Applicants who find themselves in need of this type of accommodation must present to the Homeless Persons Unit who will arrange accommodation. They then must contact Cork City Council where their homeless situation will be assessed.

Cork City Council will compile the current Housing List and notify all applicants in writing of their position.

It is envisaged to produce the Housing List in six month period, that being twice a year and duly notify applicants.

Applicants will be waiting 3 years on average before offer of accommodation.'

(Proposer: Cllr. C. O'Leary 08/084)

10. **HOUSING & COMMUNITY FUNCTIONAL COMMITTEE – 13th OCTOBER 2008**

10.1 **MONTHLY REPORT**

An Chomhairle approved the report of the Director of Services on Housing for the month of September, 2008.

10.2 **QUARTERLY REPORT**

An Chomhairle approved the report of the Director of Services on Housing for the quarter ended 30th September, 2008.

10.3 **HOUSING NEEDS ASSESSMENT 2008**

An Chomhairle approved the report of the Director of Services on the Housing Needs Assessment, 2008.

10.4 **DEVELOPMENT AT SPRIGG'S ROAD & ST. MARY'S AVENUE**

An Chomhairle approved the report of the Director of Services dated 9th October 2008 under Section 179 (3) of Planning and Development Act 2000 and the proposed development at Sprigg's Road and St.Mary's Avenue, Gurranabraher.

The report of the Director of Services stated that the proposed development will be located on a site measuring 0.16 acres (0.06 ha) situated between 58 Spriggs Road and 39 St Marys Avenue Gurranabraher, which is in the ownership of the City Council.

PROPOSED DEVELOPMENT:

The proposed development consists of a total of 3 no. dwellings.

Access to the proposed development will be through Templeacre Avenue or alternatively Sunvalley Drive via Spriggs Road.

Details of the house types and development proposed are given as follows:

3 No 3 Bedroom two storey houses.

Plans and particulars of the proposed development were available for public inspection for the prescribed period. The period within which any submissions or observations were to be made ended on the 18th September 2008.

One submission/observation indicating support for the proposed development was received within the specified period.

The site which is in the ownership of Cork City Council was overgrown and the location for illegal dumping and anti-social behaviour. The proposed Development will be carried out in conjunction with the proposed Spriggs Road Remedial Project.

There is substantial demand for social housing across the entire city. At August 28th, 2008 there were 3,668 eligible applicants seeking local authority housing with a further 1,275 applicants awaiting assessment. The proposed scheme will provide much needed accommodation and will help to meet housing demand on the Northside of the city.

The proposed development is considered to be consistent with the proper planning and sustainable development of the area having regard to the provisions of the Development Plan. The proposal has been considered by the Planning and Development Directorate, the Roads and Transportation Directorate, the Environment Directorate and the Recreation, Amenity and Culture Directorate

and all have indicated that they consider the proposed development to be acceptable.

10.5 **PURCHASE OF 56 NO. DWELLINGS AT COPPINGER'S ACRE, BANTRY PARK ROAD**

Comhairleoir D. Wallace declared an interest in this matter and removed himself from the meeting for the duration of this item.

An Chomhairle considered the report of the Director of Services dated 9th October on the proposed loan facility for the purchase of 56 no. dwellings at Coppinger's Acre, Bantry Park Road, Cork and the adoption of the following resolution:-

“RESOLVED in accordance with Section 106 of the Local Government Act 2001, Cork City Council is to borrow a sum not exceeding €13,579,142 to cover all costs associated with the purchase of 56 no. dwelling houses at Coppinger's Acre, Bantry Park Road, Cork.

On the proposal of Comhairleoir C. Clancy a vote was called where there appeared:-

“RESOLVED in accordance with Section 106 of the Local Government Act 2001, Cork City Council is to borrow a sum not exceeding €13,579,142 to cover all costs associated with the purchase of 56 no. dwelling houses at Coppinger's Acre, Bantry Park Road, Cork.

10.6 **DISPOSALS**

An Chomhairle approved the following disposal:-

- (a) Disposal of Freehold interest in property known as “Ravenscourt House” Skehard Road, Cork to Sean and Bernadette Keohane C/o William Fry Solicitors for the sum of €2,000 plus costs of €1,500.
