3. QUESTION TIME - QUESTIONS SUBMITTED ENCLOSED.

3.1 WALK-WAY BETWEEN LAGAN GROVE AND LIFFEY PARK

In response to the following question submitted by Comhairleoir J. Kelleher, a written reply was circulated as outlined below:-

Now that the decision has been made and the money allocated, will the Manager inform Council when the walk-way between Lagan Grove and Liffey Park, Mayfield, will be closed?

This item is due for discussion at a meeting of Ward Members on Monday the 22nd of October 2007. On the recommendation(s) ensuing from this meeting works can then proceed accordingly.

3.2 TRAFFIC LANE ON CAMDEN QUAY

In response to the following question submitted by Comhairleoir L. McGonigle, a written reply was circulated as outlined below:-

To ask the Manager what consultation took place before the redesignation of the traffic lane on Camden Quay to a contra flow bus corridor? And whether individual traders on the Quay were informed directly?

The implementation of the contra flow bus on Camden Quay is part of the Green Route Project for the no. 2 Bus Route from the City Centre to Knocknaheeney. The Green Route Scheme was subject to the full public consultation process under Part 8 of the Planning Regulations. This process included:-

- A public notice published in the press.
- Site notices posted along the route.
- Details of the scheme available to the public for a four week period in Cork City Council offices.
- Submissions and comments from the general public and all other interested bodies.
- A report on the submissions was made to Council and the Part 8 Process was approved in July 2005.

In addition to the above, a public exhibition of the proposals was held in the Shandon Court Hotel in Shandon which was advertised and open to the public. The proposals were also exhibited for a week in the public library in Knocknaheeney.

Traders/residents were not contacted individually; however, the public notice and the advertisement for the public exhibitions were reasonable attempts to inform the general public of the proposals incorporated in the Green Route Scheme.

3.3 **REFURBISHMENT OF ST. FINBARR'S HOUSE**

In response to the following question submitted by Comhairleoir B. Bermingham, a written reply was circulated as outlined below:-

Following a number of questions with answers that the matter will be rectified, when will Cork City Council finally ensure that St. Finbarr's House and its attached property on the Western Road will be upgraded from its unsightly sight as at present?

Following Title investigation in relation to St. Finbarr's House, we have been advised by the Solicitors for the reputed owner that a planning application will be made to develop this property.

In relation to the attached property the owner has advised that it is his intention to refurbish the property and make it available for letting.

Cork City Council will monitor developments to ensure that the undertakings given will be carried out.

3.4 PEDESTRIAN CROSSING TO CROSS THE MODEL FARM ROAD

In response to the following question submitted by Comhairleoir D. McCarthy, a written reply was circulated as outlined below:-

Regarding my motion of last year, i.e.

"(In order to provide a safe environment for the hundreds of schoolgirls that have to cross the Model Farm Road on a daily basis to access Mount Mercy School I proposed that Cork City Council would install a pedestrian crossing in the vicinity of the school gate as a matter of utmost urgency")

As the new school year has begun, would the Manager please advise us as to when we can expect this vital pedestrian crossing to be installed to ensure the safety of school children using what is one of the busiest / dangerous roads in the city?

The report on the motion referred to in this question, was dealt with and approved by Council in April of this year. The motion stated that the provision of the pedestrian crossing will be put forward for consideration to be included in the roads programme.

This year's roads programme includes work on other pedestrian crossings and no funds have been allocated for the installation of a pedestrian crossing at Mount Mercy School. It will however, be considered for inclusion in the 2008 roads programme.

Model Farm Road is a "sub route" of the Ballincollig Green Route and an examination will also be done on whether the cost of the crossing, if it is warranted, could be funded by the Green Routes Schemes.

3.5 <u>CREATION OF REHEARSAL SPACE/ UNITS IN THE CORK DOCKLANDS DEVELOPMENT</u>

In response to the following question submitted by Comhairleoir L. Kingston, written reply was circulated as outlined below:-

Has any organisation or agency been identified that is willing to act as the lead agent in relation to putting in operation the creation of rehearsal space/units as is outlined in the Cork Docklands development?

Some submissions received in relation to the Draft South Docks Local Area Plan identified the need for rehearsal space and noted that some space currently provided in the Showgrounds could be lost.

The Draft Amendments made to the Draft South Docks Local Area Plan include provision for a variety of cultural/community facilities that will provide for some rehearsal space.

It is desirable that the need for rehearsal space and meeting that need be addressed on a citywide basis as Cork Docklands is not the only location where these facilities are required and it may not be the best location in all cases.

The Recreation, Amenity and Culture Directorate in Cork City Council, working with the Docklands Directorate, would be the lead agent in delivering these facilities.

How many people do we employ in the Housing Maintenance section and how does this compare with the numbers employed on the same dates in 2005 and 2006?

3.7 **DERELICT SITES**

In response to the following question submitted by Comhairleoir J. O'Callaghan, a written reply was circulated as outlined below:-

What is the current status and intent of the apparently derelict sites at:

- Carmelite Place (6 House Terrace)
- The Crows Nest, Victoria Cross
- The former Car Showrooms at the Corner of Orchard Road and Victoria Cross Road.

1. **1-6 Carmelite Place:**

- O The Director of Services, Planning & Development has on the 13th November 2006, by Manager's Order 7533/06, declared these properties derelict, under the Derelict Sites Act 1990. The file was referred to the City Council's Property Section on the 4th December 2006, to enter the properties on the Derelict Sites Register.
- These properties are also the subject of a current planning permission (TP 07/31711), which was granted for the demolition of the 6 terrace houses /shop & for the construction of an apartment development. Permission was granted on the 25th May 2007 & the permission will expire on the 14th May 2012.

2. The Crows Nest, Victoria Cross:

- o The site is subject of a current Planning Permission (TP 05/30071) which was granted by An Bord Pleanála on the 6th July 2007, for the demolition of the existing buildings & the construction of a mixed use development. Permission will expire on the 5th July 2012.
- O Under the circumstances I would therefore consider it premature to place these properties on the Derelict Sites Register, at this time. However the Planning Authority will monitor the site for commencement of development over the coming months & will consider placing the site on the Derelict Sites Register, if we consider the condition of the site detracts to a material degree from the local amenities

3. The former Car Showrooms at the Corner of Orchard Road and Victoria Cross Road:

- o The site is subject of a current Planning application (TP 07/32295) which was submitted on the 7th August 2007. The application is the subject of a recent request for Further Information dated the 1st. October 2007.
- o Under the circumstances and as the property was being utilised up to recently as a Motor Sales Operation, I would therefore consider it premature to place these properties on the Derelict Sites Register., at

this time. However the Planning Authority will monitor the situation over the coming months & will consider placing the site on the Derelict Sites Register, if we consider the condition of the site detracts to a material degree from the local amenities.

3.8 <u>STUDENT BEHAVIOUR IN RESIDENTIAL AREAS</u>

In response to the following question submitted by Comhairleoir J. Buttimer, a written reply was circulated as outlined below:-

Will the City Manager –

- i. Indicate what meetings have taken place between City Council and representatives of CIT, UCC, FAS and CUH with respect to expectations re student behaviour in local residential areas, and comment on the outcomes or action plans arising from any such meetings?
- ii. Have there been any meetings with the relevant student bodies from these facilities and comment on the outcome of these meetings?
- iii. How many landlords have registered property for the South West Ward?
- iv. How many inspections of these properties have been undertaken and can the City Manager comment on the conclusions of these inspections?
- v. How many inspections have occurred after traditional working hours i.e. after 5.00 p.m. and can the City Manager comment on future plans with respect to inspections of properties?
- vi. What discussions have taken place between City Council and local resident associations with respect to student behaviour in residential areas and can the City Manager comment on the outcome of these discussions?
- (a) None to my knowledge. Perhaps this is more a matter for the Gardai.
- (b) No to my knowledge.
- (c) We do not possess information in regard to the total number of rented properties in the South West Ward. This is a matter for the Private Rented Tenancy Board (PRTB).
 - There are however approximately 9,000 registered properties in the city.
- (d) There are no specific figures available for the South West Ward. However, 715 inspections were carried out in 2006, in the city and 321 Improvement Notices were issued. The majority of the Improvement Notices issued were for minor breaches of the Housing (Standards for Rented Houses) Regulations 1993.
- (e) No inspections were carried out after 5.00pm. Our future plan is to maintain the level of inspections and to ensure compliance with the 1993 Regulations.

(f) No specific discussions, to my knowledge have taken place in regard to student behaviour. This is a matter for the College authorities and the Gardai.

It would be reasonable to assume that the numerical breakdown of inspections and improvement notices, for the South West Ward, would proportionately mirror those for the city as a whole.

3.9 <u>CITY HALL AVAILABLE FOR CIVIC NUPTIALS</u>

In response to the following question submitted by Comhairleoir C. Clancy, a written reply was circulated as outlined below:-

Given that from November 2007 Irish couples are no longer restricted to Church or Registry Offices as locations for a wedding ceremony and following on a Motion I had before Council in July 2005 on making City Hall available for Civic Nuptials –

Ask the Manager

Has an area within City Hall been identified for Civic Nuptials to take place?

From November 2007, the marriage provisions of the Civil Registration Act, 2004 will be commenced and will replace the current marriage legislation in Ireland.

From the 5th November it will be possible for civil marriages to be held at venues other than Registry Offices, provided the venue has been inspected and approved by the HSE in advance of the marriage ceremony and subject to a Registrar being available to solemnnise a marriage at that venue on the date in question.

Under the provisions of the Act, the onus is on the couples who wish to have a civil ceremony at a venue other than the Registry Office to acquire the prior approval of the owners of that venue.

This venue will then be identified in the Notification of Intention to marry which must be given to the Registrar. Following this the registrar will contact the owner to arrange for an inspection.

If and when a request is received from a couple wishing to have a ceremony in City Hall then the matter will be considered at that stage.

3.10 KINSALE ROAD PARK & RIDE FACILITY

In response to the following question submitted by Comhairleoir M. Ahern, a written reply was circulated as outlined below:-

- (a) What was the Capital Cost of the Kinsale Road Park & Ride facility?
- (b) How many parking spaces are provided there?

- (c) What is the Capital Cost per space provided?
- (d) What was the average income per space provided in the year to end of 2006?
- (e) What was the average expenditure (excluding capital but including the cost of direct wages and salaries and transport to and from town) per space provided in the year 2006?
- a) The capital expenditure was €7 million excluding the value of the land which was in Cork City Council ownership. The capital works included a large amount of costly "remedial works" for the former landfill site.
- b) There are 910 spaces are provided at the Park & Ride facility
- c) The capital cost per space provided was €7,700 per space excluding land value.
- d) The average income is €810 per space
- e) The average expenditure is €749 per space

3.11 **DEANROCK REGENERATION**

In response to the following question submitted by Comhairleoir F. Dennehy, written reply was circulated as outlined below:-

To ask the Manager if there are any further developments / plans in relation to the Deanrock Regeneration.

Work on the demolition of the Deanrock Flats was completed earlier this year with a view to advancing re-development proposals on a Public Private Partnership Design-Build basis. No detailed plans are in place as yet - a development brief for the site is being worked up in order to publicly advertise for proposals.

The need to integrate proposals with the existing commercial concerns on-site (the bank and credit union) will require to be addressed in the development proposals and the Council has been liaising with both of these parties in relation to their requirements in this regard.

Also, the Health Services Executive has proposals for the development of a Health Facility in the area and has requested to be incorporated in the proposed development scheme for Deanrock. The HSE is currently finalizing it's detailed requirements and a meeting is being arranged for later this month to progress this issue.

A further meeting will be arranged in due course with Ward Members to advise them in relation to the detail of the final brief.

4. FINANCIAL STATEMENT TO 30th SEPTEMBER, 2007

An Chomhairle approved the Financial Statement to 30th September, 2007. The City Manager agreed that a Quarterly Capital Report would be circulated in future.

6.1 QUARTERLY REPORT ON LEISURE AND LIBRARY FACILITIES

An Chomhairle approved the Quarterly Report on Leisure and Library Facilities.

6.2 REPORT OF A/DIRECTOR OF SERVICES ON EXTENSION WORKS AT LEISUREWORLD

An Chomhairle considered the report of the A/Director of Services dated 9th October 2007, on extension works to Leisureworld.

On the proposal of Comhairleoir J. O'Brien, seconded by Comhairleoir C. O'Leary, a vote was called for on the deferral of the report where there appeared as follows:-

An tArd-Mhéara declared the vote carried and the report carried.

The report of the Director of Services stated that Leisureworld at Bishopstown has been operating successfully since opening in February 1997. The complex at that time comprised of a 25m swimming pool, a children's learner pool, gym, aerobics room, sauna, steamroom and associated changing facilities. Since then, to cater for demand, and from Leisureworld's own resources, an additional 18m pool has been added, the gym has expanded twice, four All Weather Pitches have been added as well as a café and extended changing facilities. The facility attracted over 500,000 visits last year.

Plans have now been prepared to extend the facility further. It is proposed to extend the present gym facilities by 296 sq. meters, provide four offices and extend the present café. The gym needs to be expanded to allow Leisureworld offer a complete range of cardiovascular and resistance equipment to its customers, including also Ladies Only, over 55's, and GP referral groups, additional facilities for younger children, and also compete successfully with other facilities, the gym always being a major attraction at Leisureworld. The company now employs 60 staff (both full time and part-time) at Bishopstown.

With only one office provided in the original complex, office accommodation is entirely inadequate at present for the staff, the company not alone managing the Bishopstown Centre, but also responsible for other facilities such as the Sam Allen Centre, Churchfield Leisure Centre and Mahon Golf Course with key operational and administrative staff based at Bishopstown.

The proposal was advertised in accordance with Part 8 (Article 81) Local Government (Planning & Development) Regulations 2001 on the 29th June 2007, with no submission being received by closing date for same 10th August 2007. The proposal is in accordance with proper planning and development of the area, there being no detrimental impact on the visual amenity and the proposal enhancing existing recreational facilities.

The proposed works are estimated to cost € 1.6m including VAT and fees. It is projected that revenues generated from the enhanced facilities will cover the costs over ten years. For cashflow purposes it is proposed that Cork City Council would provide an interest free loan of €1m, repayable in equal installments over ten years, with the balance being funded from Leisureworld's own resources. At the end of the period, the asset, having been amortised in Leisureworld's accounts, will revert to Cork City Council at no cost.

Leas Ard Mhéara T. Shannon assumed the chair.

6.3 PART 8 REPORT ON EXTRA ALL WEATHER PITCHES AT THE GLEN RESOURCE CENTRE

An Chomhairle considered the proposed development on the provision of additional two All Weather Pitches and Car Parking at the Glen Resource and Sports Centre, Glen Avenue and the report of the A/Director of Services dated 10th October 2007 thereon. On the proposal of Comhairleoir J. Corr, seconded

by Comhairleoir D. Wallace, An Chomhairle approved the proposed development and the report of the Director of Services thereon.

The report of the Director of Services stated that the Glen Resource Centre is owned by Cork City Council and has been operating very successfully since it opened in 2001. The facility comprises of six All Weather Pitches, changing areas, Crèche and offices.

To cater for demand for pitch hire, it is proposed to construct an additional two pitches and extend car parking by 19 car spaces. The project is one of the projects approved by Council last year as part of the North City Environmental Enhancement Action Plan.

The proposal was advertised in the Examiner on the 15th June 2007 in accordance with Part 8, Local Government (Planning & Development) Regulations 2001m, with no submission being received by closing date of 27th July 2007. The proposed development is in accordance with proper planning and development of the area and will enhance the recreational facilities in the area further. Works will cost €260k approximately and will be completed within the next few months.

6.4 **50 M SWIMMING POOL**

An Chomhairle considered the report of the A/Director of Services dated the 10th October 2007, on the following motion which was referred to the Committee by An Chomhairle:-

'To satisfy the phenomenal need, and to further promote sport in Cork City, I propose that Cork City Council would ensure that a 50 meter swimming pool be built in the City.'

(Proposer: Cllr. D. McCarthy 07/240)

On the proposal of Comhairleoir D. McCarthy, seconded by Comhairleoir J. O'Callaghan a vote was called for on the report of the A/Director of Services where there appeared as follows:-

An tArd-Mhéara declared the vote carried and the report of the A/Director of Services approved.

The report of the A/Director of Services stated that the City Council over the years has been a major provider of swimming facilities within the City. Currently there are three 25m pools provided, Leisureworld, Bishopstown (which also has an 18m pool), Churchfield Leisure Centre and the Gus Healy Pool at Douglas. The Council committed over €5m of its own resources to provide the facility at Churchfield in 2005, with total cost being €9.5m. Council at its meeting of 27th February 2006 also committed itself to provide a new 25 m pool at Douglas and is awaiting a response in relation to its request for grant aid for same, total cost likely to be €10m approx.

Given the three pools (with new pool at Douglas) and the proliferation of private leisure centres in recent years, the swimming needs of the City are considered to be well catered for at present. The capital cost of providing a 50 m pool is considerable, with the 50m capacity generally not being used except for specialised hours for elite swimmers. In effect, a 50 m facility is only used by a tiny portion of the swimming community, but attracts huge capital and operational costs − the National Aquatic Centre is expected to lose over €1m this year. Whilst inconvenient, the needs of a small number of elite swimmers in the City can be catered for at the 50m pool at the University of Limerick. The provision of a 50m pool by the Council cannot be justified with the priority being construction of a new 25m public facility at Douglas.

An tArd Mhéara assumed the chair again.

6.5 MUNICIPAL PITCH AND PUTT COURSE AT LOTAMORE

An Chomhairle approved the report of the A/Director of Services dated the 10th October 2007, on the following motion which was referred to the Committee by An Chomhairle:-

'That Cork City Council take steps to acquire lands at Lotamore for the purpose of constructing a Municipal Pitch & Putt Course to be run on a not for profit basis.'

(Proposer: Cllr. T. Brosnan 07/249)

The report of the A/Director of Services stated that the Cork Recreational Facilities Needs Study (2003) identified a short-fall in the provision of pitch and putt courses in the Northside of the City with no provision in the North East, the report also highlighted that there is not suitable available space within the City Boundary to provide a course.

A Pitch and Putt course requires an area of 4.5 to 5 acres. Criteria for location must satisfy accessibility, supervision, safety in terms of proximity to public areas, roadways and housing and be relatively free draining.

During the consultation for the Recreation Facilities Needs Study (2003), there was no expressed demand for a pitch and putt course in the North East.

However, should a course be provided and managed, the belief is that it would be well used particularly by juveniles.

The cost to develop an 18 hole course excluding cost of land but including a small pavilion and machinery depot is estimated at \in 1.2 million. The total cost could exceed \in 1.5m and annual maintenance would be in the order of \in 70,000. It is desirable that the extent of local demand be established before proceeding to acquire a site particularly in the light of the 2003 study.

6.6 <u>MONUMENT IN MEMORY OF THE LATE CLLR. CON</u> <u>O'CONNELL</u>

An Chomhairle approved the report of the A/Director of Services dated the 10th October 2007, on the following motion which was referred to the Committee by An Chomhairle:-

'That Cork City Council will erect a fitting monument in the form of a park bench with a plaque, in memory of the late Alderman, Cllr. Con O'Connell and in recognition of his contribution to politics in Cork and in particular Cork South-Central. That the City Council commission this monument without delay and locate it at the Lough in the heart of Cllr. O'Connell's constituency of South Central.'

(Proposer: Cllr. C. O'Leary 07/254)

The report of the A/Director of Services stated that the family of the late Cllr. Con O'Connell will be consulted about the proposal and if agreeable, arrangements will be put in hand to erect the seat and plaque at the Lough.

6.7 TREES ON MOUNT CARMEL ROAD, GREENMOUNT

An Chomhairle approved the report of the A/Director of Services dated the 10th October 2007, on the following motion which was referred to the Committee by An Chomhairle:-

'That the trees be pruned on Mount Carmel Road, Greenmount immediately. This overgrowth is a cause of concern to residents living in this area because children cannot play safely. The foliage has now become so overgrown the motorists driving through this road cannot see the children playing there.'

(Proposer: Cllr. L. Kingston 07/256)

The report of the A/Director of Services stated that the sucker growth on the above trees has now been pruned.

6.8 SUMMER STREET AMBASSADOR SCHEME

An Chomhairle approved the report of the A/Director of Services dated the 10th October 2007, on the following motion which was referred to the Committee by An Chomhairle:-

'That Cork City Council would in conjunction with other organisations introduce a Summer Street Ambassador Scheme to assist tourists. A similar scheme introduced in Limerick last year has been very successful and is being replicated in Dublin this year.'

(Proposer: Cllr. T. O'Driscoll 07/261)

The report of the A/Director of Services stated that the Limerick Coordination Office ran the Limerick Street Ambassador Scheme from 2006 – 7 and plans to run the scheme again in 2008.

The programme operates from the 1st June – 30th August. It involves the employment of 9 Street Ambassadors plus a Supervisor. Street Ambassadors assist the public, serving in a 'welcoming and informative role for visitors'. They also serve a secondary function observing the environmental condition of the City Centre.

This project is funded under a European programme called SPAA – Sustainable Promotion of Atlantic Area an Interreg IIIB project. The SPAA project seeks to promote the economic development of European towns, cities and regions in a sustainable and innovative way. The project involves partners from Europe – Chester (UK), Ourense (Spain), Valimar (Portugal) as well as Limerick. All are seeking to address some of the economic challenges they face as sub regional hubs on the periphery of not only their own regions but also their own countries and the EU as a whole. There are pilot demonstration projects in each partner's region and the Ambassador programme which is new to Ireland but has been long

established in City Centres across the EU, was a pilot project carried out by Limerick.

Training and employment costs for the project in 2007 were €22,230, (EU funding) with associated costs of €5,000 toward uniforms, logos etc. These latter costs were met by Shannon Development and the Limerick Chamber of Commerce. Thus the total costs for 2007 were €27,230.

The Limerick Coordination Office promotes the centre of the city as an attractive, safe and enjoyable place for businesses, residents and visitors. It is funded by Limerick City Council, the Shannon Development Authority and the Limerick Chamber of Commerce, as well as the project based funding it receives from the EU.

The scheme has met with widespread public and media support. The Ambassadors can also serve to usefully point out problems experienced by visitors to the City leading to early and quick responses.

It is proposed that the feasibility and merits of such a scheme will be investigated further with Cork City Marketing Partnership, the equivalent organisation in Cork to the Limerick Coordination Office.

6.9 TREES, ARDMAHON ESTATE

An Chomhairle approved the report of the A/Director of Services dated the 10th October 2007, on the following motion which was referred to the Committee by An Chomhairle:-

'That the trees in the park at Ardmahon Estate be topped this year, as they have grown to be a very dangerous height.'

(Proposer: Cllr. T. Shannon (07/279)

The report of the A/Director of Services stated that the necessary pruning works to reduce the height of the above trees also been carried out.

6.10 COMMUNITY CENTRE IN FAIRHILL

An Chomhairle approved the report of the A/Director of Services dated the 10th October 2007, on the following motion which was referred to the Committee by An Chomhairle:-

'That Cork City Council would examine the viability of providing a Community/ Health Centre for the Fairhill area. The residents of the area have been campaigning for many years for a Community Centre for the area. Fairhill is the most expanded community in the North Side of the City with no community facilities of its own. This should be seriously addressed in conjunction with the proposed development of a new park in Bridevalley Park'

(Proposer: Cllr. M. O'Connell 07/314)

The report of the A/Director of Services stated that Fairhill Residents Association have received funding of €30k from Dormant Accounts towards a feasibility study in relation to need for a community centre etc., in the wider Fairhill Area. A meeting will be arranged within the next few weeks between the RAPID Co-ordinator, City Council, other Agency representatives and the Resident's Association to review progress.

6.11 FITZGERALD PLACE, OLD BLACKROCK ROAD

An Chomhairle approved the report of the A/Director of Services dated the 10th October 2007, on the following motion which was referred to the Committee by An Chomhairle:-

'That Fitzgerald Place, Old Blackrock Road be immediately investigated with a view to:-

- (a) cutting back the trees up the centre of the Avenue
- (b) prepare the damage to the road resurface, which has been caused by the roots and has left the surface in a very dangerous condition.'

(Proposer: Cllr. S. Martin 06/349)

The report of the A/Director of Services stated that:-

- (a) Remedial tree pruning on the trees at Fitzgerald's Place will be carried out within the next four to six weeks.
- (b) Roads Dept. will inspect the damage caused to the road surface and carry out any repairs considered necessary.

6.12 PARKOWEN – RECREATION & LIVING SPACE

An Chomhairle approved the report of the A/Director of Services dated the 10th October 2007, on the following motion which was referred to the Committee by An Chomhairle:-

'That the open spaces adjacent to Park Owen be immediately C.P.O. and that Housing and Recreation prepare a plan for the future development of the Park as a recreational and also a living space.'

(Proposer: Cllr. S. Martin 06/386)

The report of the A/Director of Services stated that the enclosed area of land situated adjacent to Park Owen Amenity Area and to the rear and side of properties at Douglas Street, Blue Anchor Lane and East View Terrace is in private ownership. The original owner who assembled small individual plots in the 1990's is now deceased and his Estate is being administered but I understand that it is intended to develop the lands and initial discussions have taken place with Planning Dept. in regard to same.

While the adjoining amenity area is in good condition, the 8 no. decorative public lamps standards have been vandalised and are not working. The cost to replace the lamps is estimated at \in 8,000 and this will be included in the 2008 Draft Estimates for consideration. Tree planting on the green areas will be undertaken in the 2007/2008 planting season.

6.13 **YOUTH CENTRE IN FARRANREE**

An Chomhairle approved the report of the A/Director of Services dated the 10th October 2007, on the following motion which was referred to the Committee by An Chomhairle:-

'I propose that Cork City Council would provide a youth centre in Farranree to serve this and surrounding areas.'

(Proposer; Cllr. D. McCarthy 07/313)

The report of the A/Director of Services stated that Funding has been secured for a feasibility study into community facilities including needs of youth in the wider Fairhill area which adjoins Farranree.

Completion of this study will allow for any specific needs in relation to youth in the area to be identified and any gaps in provision to be addressed by the relevant agencies/youth organisations working in the Farranree/Fairhill area.

6.14 TORY TOP PARK

An Chomhairle approved the report of the A/Director of Services dated the 10th October 2007, on the following motion which was referred to the Committee by An Chomhairle:-

'That the number of Children's Play facilities in Tory Top Park be increased.'

(Proposer: Cllr. T. O' Driscoll 07/215)

The report of the A/Director of Services stated that Play facilities at Tory Top Park consist of Playground Equipment for toddlers up to six years and older children up to twelve years. The playground was completely renewed in 2005 with the provision of more challenging play equipment, safer surfacing, bench seats and litter bins.

A new Skate Park was installed in June 2006 and this is extremely popular with all age groups and in particular with juveniles and young adults.

A Multi-User Games Area is scheduled to be installed in October/November 2007 increasing further the variety of play activities in the Park.

Due to the considerable increased use of the Park and play facilities, parents have requested that some additional items of play equipment be provided to cater for the sizeable number of children using the facilities.

To cater for this increased demand, it is intended that additional items of play equipment amounting to approximately €30,000.00 be included in the 2008 Parks Capital Programme for consideration.

Transport: To promote various transport alternatives to cars and to take measures to switch Cork City Council vehicles to renewable energy sources. To engage with public transport providers, including Bus Eireann, and to advance policies which are keeping with this motion.

Planning: Develop planning guidelines for development of lands at risk of flooding, under current climate change forecasts and to ensure that all developments are socially & environmentally sustainable. Develop integrated actions on spatial planning to reduce commuting and other sources of carbon emissions.

Energy generation: That action is taken to increase the use of renewable energy sources in heating existing buildings and new developments and that fitting renewable energy sources be standard in renovation programmes for Cork City Council properties.

Biodiversity: Develop policies to protect sensitive habitats from the negative impacts of climate change.

Policy Proofing: Ensure all policy developed by Cork City Council is environmentally and ecologically proofed to meet the highest international standards.'

(Proposer: Cllr. C. O'Leary 07/268)
