2. <u>MINUTES</u>

The Minutes of the Ordinary Meeting of An Chomhairle held on 12th February 2007 were considered and approved.

3. *QUESTIONS*

3.1 WATER MAIN ON UPPER PATRICK ROAD

In response to the following question submitted by Comhairleoir S. Martin, a written reply was circulated as outlined below:-

What is the delay in repairing the water main on Upper Patrick Road, Turners Cross?

The water main on Upper Patrick Road, Turners Cross is part of an ageing network and suffers from poor pressure. It has been the subject of leaks in the past leading to remedial works as and when necessary. The replacement of this section of watermain will cost circa \notin 92,000 and plans for this work will be prepared with a view to execution in the current year. In the meantime the Council will continue to effect repairs as necessary to maintain adequate water pressure.

3.2 DERELICT, UNSIGHTLY PROPERTIES ON THE WESTERN ROAD

In response to the following question submitted by Comhairleoir B. Bermingham, a written reply was circulated as outlined below:-

Will the Manager please explain:-

- 1. Why Cork City Council continues to tolerate the derelict unsightly properties on the Western Road, to which I previously referred with a question to the Manager?
- 2. How long more must the Residents of Bishopstown put up with the unsightly hording surrounding Hawkes Road/Bishopstown Road, Bishopstown?
- 1. The relevant properties nos. 1, 2, 3, 4 & site between 2 & 3 University Place, Western Road (east of O'Donovan's Road) were inspected by the Planning Authority & having been considered derelict as defined under Section 3 of the Derelict Sites Act, 1990 were recommended to the Property Department on the 10th November, 2006 for inclusion on the Derelict Sites Register.

The Property Dept carried out title investigations on the properties and arising from these a Section 29 notice was issued to an identified owner. Confirmation has been received that refurbishment work has commenced on nos. 2 and 3 with a view to having the properties available for letting in the next few months.

2. This site is being prepared for a recently permitted development and it is entirely reasonable for developers to erect hoardings to building sites in order to prevent unauthorised access. Any measure to enhance the safety of the public and employees is to be welcomed.

3.3 NO. 66 TORY TOP ROAD, BALLLYPHEHANE

In response to the following question submitted by Comhairleoir T. O'Driscoll, a written reply was circulated as outlined below:-

When is it proposed to bring the proposed purchase of freehold interest at No.66 Tory Top Road, Ballyphehane to the City Manager and City Council for approval?

The Section 183 Disposal Notice for the above property was approved by Council at its meeting held on 16th January, 2006. Instructions were then given by the Property Department to the Law Agent to progress this matter. The Law Agent has issued correspondence to the applicant's solicitor and is awaiting a response to this correspondence.

3.4 <u>SPEED RESTRICTION SIGNS IN THE VICINITY OF MOUNT MERCY</u> <u>SCHOOL</u>

In response to the following question submitted by Comhairleoir D. McCarthy, a written reply was circulated as outlined below:-

Following the Managers answer to my query on this subject over a year ago in which he stated that he was to liaise with An Garda Siochana as to the feasibility of installing speed restriction (limit) signs in the vicinity of Mount Mercy School, Model Farm Road, as an urgent safety measure.

Can the Manager now tell me:

- a. When the meeting with An Garda Siochana took place?
- b. Provide me with the most up to date information he has on this matter?

Meetings and discussions are held with the "Traffic Gardaí" almost on a daily basis and the use of speed repeater signs on Model Farm Road were discussed with the Gardaí in November 2005 when the matter was reported to Council. At the time it was agreed that motorists could not be in any doubt that they were in a 50 kph zone.

However, we do use repeater signs on some roads in Cork City on a very selected basis, to encourage motorists to slow down. We have to be careful though, that they are not provided in a widespread manner so that ambiguous or confusing messages could be given to motorists on roads, which do not have repeater signs.

Work is due in the coming months on the provision of new road markings, cycle tracks, etc. on Model Farm Road as part of the Green Routes Projects, and we will arrange for the installation of some repeater signs on the roadway as part of the 'package' of traffic calming measures in the area.

3.5 KNOCKNAHEENY MASTER PLAN – KILLALA GARDENS

In response to the following question submitted by Comhairleoir T. Fitzgerald, a written reply was circulated as outlined below:-

- a. **Housing** That as a matter of urgency he will include the entire estate of Killala Gardens for submission to Government for a major refurbishment programme (included in the Black EFGH Submission) to address the dampness and overcrowding which affect the health and well being of many residents.
- b. **Recreation & Amenities** That this area is included for tree planting and clean up of green areas.
- c. How advanced are the plans to develop the green area at Killala Gardens close to Nu Farm Pitch and close to Churchfield Green.
- d. **Housing** How soon will a meeting with the Ward Members be held to update them on the submissions and concerns by residents of Black EFGH.

(a) The proposals for Blocks EFGH have been advertised formally under the Part 8 Planning Process and are currently the subject of ongoing consultations with residents' representatives. At this stage it is not possible to include Killala Gardens with these proposals. Plans for Killala Gardens will be advanced in the coming months as part of the next phase of the Knocknaheeny Regeneration Project.

(b) Cleaning will be undertaken and extensive tree planting on the green area at Killala Gardens will be carried out during March/April as part of the North City Environmental Enhancement Plan.

(c) Grant-aid approval under the Rapid Playground Programme for the provision of a Multi Use Games Area on the green area close to Churchfield Green is due shortly. The MUGA is scheduled to be installed by July 2007 and improvements to the adjoining green areas will be undertaken as part of this work. At this stage no further plans have yet been advanced to develop the green area close to Nu Farm pitch. The future use of the area will be reviewed in the context of the North West Area Office moving to new premises in the Block D project and the existing Open Space zoning of the land. A further report will issue in due course.

(d) Four meetings with tenant representatives were to be organised in relation to the advertised proposals for Blocks EFGH. Two of these meetings have been held with a further meeting scheduled for later this week. It is anticipated that following completion of these meetings Ward Members will be briefed early in March.

3.6 SALE OF PORTION OF THE TANK FIELD

In response to the following question submitted by Comhairleoir T. Brosnan, a written reply was circulated as outlined below:-

In relation to the proposed sale of portion of the Tank Field to the Department of Education can the Manager please confirm his best estimate of the price and can he breakdown what it will be used for by Cork City Council.

Monies that are received from the sale of assets are retained for capital purposes. They go into a General Capital Fund and are allocated to Capital Projects throughout the city from time to time. Net income in the case of the Tank Field will be in the region of $\in 669,000$.

Proposals to enhance public amenities in the surrounding areas including the Mayfield, Montenotte and Murmont areas will be considered on their merits for the allocation of the necessary funds from this central fund.

Considerable monies have already been allocated from the General Capital fund for projects in this area.

3.7 CORK CITY OF FAIR TRADE

In response to the following question submitted by Comhairleoir C. Lynch, a written reply was circulated as outlined below:-

To ask the City Manager for an update on the measures carried out in relation to my motion of last September regarding Cork City Council putting in place the appropriate requirements in order for it to become "A City of Fair Trade".

Cork City has already got the status of a Fair trade City arising from the work of a voluntary group and formal decision of Council. The city has met the conditions necessary for the designation and signs publicising the designation have recently been erected.

A report was submitted to the Planning and Development Strategic Policy Committee on Cllr. Lynch's Motion at its meeting of 24th November 2006.

CORK AS A FAIRTRADE CITY

That Cork City Council will set about the process of becoming a Fairtrade City and in pursuit of this goal set out to achieve the following objectives within a specific timeframe:

- Establish a Fairtrade steering group with relevant agencies/stakeholders to ensure that Cork City meets all requirements to be registered as a Fairtrade City and to ensure a continued commitment to maintaining its Fairtrade status.
- Council to pass a resolution supporting Fairtrade.
- Council to encourage relevant business within the City to have Fairtrade products.
- Council to erect street signs declaring Cork as a Fairtrade City and produce a Fairtrade Directory advising people where Fairtrade products can be bought.'

(Proposer: Cllr. C. Lynch 06/420)

Decision of Committee

It was agreed to hold the Motion and the Directors report in Committee to allow the Director of Services, Community & Enterprise to include in a further report matters relating to other organizations/groups and government initiatives promoting ethical production of goods.

The recommendation of the SPC will be brought to Council for decision following the SPC meeting of 12^{th} March.

3.8 **PROCESS INVOLVED IN THE EVENT OF BIRD FLU**

In response to the following question submitted by Comhairleoir J. Buttimer, a written reply was circulated as outlined below:-

To ask the City Manager to outline to Council the procedure, role of Cork City Council and process involved in the event of Bird Flu, highly Pathogenic Avian Influenza (HPAI) breaking out in Cork City.

Monitoring and control of Class A animal diseases including Avian Influenza is the responsibility of the Department of Agriculture and Food. The Department has prepared contingency plans to deal with the unlikely event of an outbreak. A number of meetings have been held between the Department and relevant agencies since October 2005, the City Councils Chief Veterinary Officer attending a number of same.

At present, the Department is collecting all dead birds likely to carry the disease (migrating water fowl) and native birds if more than two are found dead in the same location. The City Council is co-operating fully with the Department and has procedures in place in relation to any dead birds found in amenity areas, with staff being advised on safety procedures relating to handling of same etc.

The Department has established a helpline 1890 252 283 to deal with any queries.

3.9 UPROOTED TREES OUTSIDE THE CENTRAL FIRE STATION

In response to the following question submitted by Comhairleoir J. Kelleher, a written reply was circulated as outlined below:-

Bearing in mind the importance of preserving all trees in the city, will the Manager explain why the mature trees outside the Central Fire Station in Anglesea Street were all uprooted and removed?

The Alder trees outside the Fire Station were planted in the early 1980's and were initially planted close together to give maximum visual impact. The close planting prevented the trees from developing balanced crowns and clear main trunks which rendered them potentially dangerous and liable to be blown over in high winds. Given the proximity of the trees to the Fire Station Building and the public footpath it was necessary to remove them in the interests of public safety.

It is worth noting that the Council has allocated \notin 300,000 under the North City Environmental Enhancement Action Plan for tree planting at various locations in the Northside during 2007. An additional \notin 135,000 is provided in the 2007 Parks Estimates for tree planting throughout the City.

4. <u>PART XVI PLANNING AND DEVELOPMENT ACT 2000- ST. PATRICK'S</u> <u>DAY PARADE – 17th MARCH, 2007</u>

On the proposal of Comhairleoir J. Corr, seconded by Comhairleoir T. Shannon An Chomhairle approved the City Manager's report dated 22nd February 2007 on the proposed holding of St. Patrick's Day Parade on 17th March, 2007 pursuant to section 238 of the Planning and Development Act 2000.

5. CORK MARKETING PARTNERSHIP

An Chomhairle agreed to defer the nomination of a member to the Board of the Cork Marketing Partnership to the next meeting of An Chomhairle.

6. <u>CIVIC RECEPTIONS</u>

An Chomhairle approved the hosting of the following Civic Receptions:-

- (a) For the Mercy University Hospital who celebrate their 150th anniversary this year.
- (b) For the Chartered Institute of Management Accountants.

7. CORPORATE POLICY GROUP – 19th FEBRUARY 2007

7.1 FINANCIAL STATEMENT TO 31ST JANUARY 2007

An Chomhairle approved the Financial Statement to 31st January 2007.

7.2 <u>SALE OF TANK FIELD</u>

An Chomhairle approved the report of the City Manager dated 19th February 2007 on the following motion which was referred to the Group by An Chomhairle:

'That Cork City Council use monies it receives from the sale of portion of the Tank Field to OPW to enhance public amenities in the surrounding area including Mayfield, Montenotte and Murmont.'

(Proposer: Cllr. T. Brosnan 07/023)

The report of the City Manager stated that monies that are received from the sale of assets are retained for capital purposes. They go into a General Capital Fund and are allocated to Capital Projects throughout the city from time to time.

Proposals to enhance public amenities in the surrounding areas including the Mayfield, Montenotte and Murmont areas will be considered on their merits for the allocation of the necessary funds from this central fund.

Considerable monies are already being allocated from this fund for projects in this area.

7.3 **PROTOCOL - ST. PATRICK'S DAY PARADE**

An Chomhairle approved the report of the City Manager dated 19th February 2007 on the following motion which was referred to the Group by An Chomhairle:

'That Cork City Council would ask the organizers of the St. Patrick's Day Parade to depart from the normal protocol where Councillors review the parade from the reviewing stand and instead to invite the members of Cork City Council to walk in the parade led by our Lord Mayor before taking up their seats in the reviewing stand.'

(Proposer: Cllr. M. O'Connell 07/050)

The report of the City Manager stated that participants in the St. Patrick's Day Parade are generally assembled at least one to two hours in advance of the start of the parade. This is to facilitate the introduction of the necessary traffic controls and road closures, well in advance, to facilitate pedestrians arriving to view the parade.

Councillors attend religious services, in cathedrals, as well as attending a wider gathering of religious and laity in both Bishops palaces.

Councillors are already under considerable time pressure on the day in order to arrive at the reviewing stand. Having considered the matter and the consequences

of a delay in the starting time of the parade such a proposal would not be practical.

8. <u>SPORT COMMITTEE - 19th FEBRUARY 2007</u>

8.1 **LEASE APPLICATIONS**

An Chomhairle approved the report of the Director of Services dated 15th February 2007, in relation to applications for 99 year Sporting Leases from Avondale United (Beaumount) and Kilreen Celtic (Tory Top park), formal Disposal Notices to be brought before Council at a later date.

9. <u>RECREATION AMENITY & CULTURE FUNCTIONAL COMMITTEE –</u> <u>19th FEBRUARY 2007</u>

9.1 **QUARTERLY REPORT ON LEISURE AND LIBRARY FACILITIES**

An Chomhairle noted the Quarterly Report on Leisure and Library Facilities.

9.2 **2007 ARTS GRANTS**

An Chomhairle approved the recommendations from the Arts Committee in relation to 2007 Arts Grants.

9.3 PART 8 REPORT ON MARINA NATURE PARK

An Chomhairle considered the proposed development of a new park at the Blackrock end of the Marina comprising of adventure playground, car park area, nature area etc. and the report of the Director of Services dated 15th February 2007 thereon. On the proposal of Comhairleoir T. Shannon, seconded by Comhairleoir J. Corr, An Chomhairle approved the Part 8 report of the Director of Services.

The report of the Director of Services stated that plans have been prepared for the development of a new park at the Blackrock end of the Marina comprising adventure playground, car park area, nature area etc. The aim of the playground will be to provide an activity based theme trail for older children (7 - 12 years approx) and a themed playground for younger children (6 years and under). The rest of the park will also provide a playful environment for children and will include a turf labyrinth, grass mounding and a wildflower meadow.

The proposal was advertised in the Examiner on the 15th December 2006 in accordance with Part 8 of the Local Government (Planning & Development) Regulations 2001 with no submission received by closing date for same 2nd February 2007.

The proposal is in accordance with proper planning and development of the area, enhancing an existing Public Open Space and is included in the Blackrock Village Area Action Plan (April 2006) as an objective for the site. The proposed works are costed at €300k approx and scheduled to commence in Summer.

9.4 EXTRA ALL WEATHER PITCHES – SAM ALLEN SPORTS COMPLEX

An Chomhairle rejected the report of the Director of Services dated 15th February 2007 on the following motion which was referred to the Committee by An Chomhairle.

'Due to the huge demand from residents of my Ward, I propose that extra all weather pitches be made available in the Sam Allen Sports Complex.'

The report of the Director of Services stated the Sam Allen Centre at Churchfield now comprises eight All Weather Pitches, with six being originally constructed in 1998, with a further two added in late 2004. As already reported previously to Council, the topography of the Churchfield site does not lend itself to further development without considerable expense, land falling steeply away from present pitches.

The Council is providing €300k to St. Vincent's Hurling & Football Club who will be constructing a full size All Weather Pitch at their nearby lands at Kilmore Road shortly. In addition two more All Weather Pitches will be constructed this year at the Glen Resource Centre bringing the total complement to eight pitches. Na Piarsaigh Hurling & Football Club at Fairhill also have plans to develop an All Weather Pitch, complementing their indoor hurling alley. Taking all these developments into consideration, the greater Churchfield area will be well catered for in terms of artificial pitch provision.

9.5 CORK LOUGH USER GROUP

An Chomhairle approved the report of the Director of Services dated 15th February 2007 on the following motion which was referred to the Committee by An Chomhairle.

'In order to manage The Lough more efficiently in relation to issues like water quality, management and welfare of the bird and fish life and general maintenance of this important amenity, we are proposing that a Cork Lough User Group be set up, spearheaded by Cork City Council's Recreation, Amenity & Culture Directorate and involving representatives of local residents, fisherman, experts from UCC and An Garda Siochana etc.

(Proposer: Cllr. M. Shields, Cllr. S. Martin – 06/534)

The report of the Director of Services stated that the Lough is a wildlife sanctuary and is one of the most valued, and used amenities within the City, with a full time Caretaker employed by the Parks Department to help maintain it to a high standard. Draft bye-laws will shortly be prepared for The Lough and it would be opportune to arrange a meeting of interested parties as mentioned in the motion to consider both the draft bye-laws and other matters relating to The Lough. If sufficient interest is expressed, regular meetings could be held by this Lough User Group with a view to further enhancing the amenity, managing the welfare of the bird and fish life etc.

9.6 KENNEDY PARK

An Chomhairle approved the report of the Director of Services dated 15th February 2007 on the following motion which was referred to the Committee by An Chomhairle.

'That proper railings be put around Kennedy Park and that all the entrances be made wheelchair accessible and that car parking be prohibited across the entrances to the park.'

(Proposer: Cllr. S. Martin 06/176)

The report of the Director of Services stated that Kennedy Park was identified in the Docklands Developments Strategy 2001 as a significant open space area in the Docklands with potential to be linked to Kennedy Quay by the provision of an additional linear open space strip. The future layout for Kennedy Park and the potential link with Kennedy Quay is being considered under the Draft South Docks Local Area Plan. This plan is scheduled to be presented to the Docklands Policy Committee in early March. In view of the above, it would be premature to erect railings around the perimeter of the park at this time.

In regard to wheelchair access, a wheelchair ramp was constructed at the entrance to the park from Blackrock Road in 2006, the entrance to the park from Monahan's Road is directly off the public roadway and therefore it is considered unsafe to provide a ramp at this location.

The issue of prohibiting car parking at the entrances will be addressed in conjunction with the Council's Traffic Dept.

9.7 PLAYGROUND, THE GLEN

An Chomhairle approved the report of the Director of Services dated 15th February 2007 on the following motion which was referred to the Committee by An Chomhairle.

'That Cork City Council expedite the construction of a children's playground in the Glen.'

(Proposer: Cllr. T. Brosnan 07/006)

The report of the Director of Services stated that the Council wishes to construct a playground in the Glen and is in discussions with Church authorities at present regarding an identified suitable site for same. It is hoped to bring a further report to Council at an early date.

9.8. <u>CONTINUATION OF MEETING</u>

An Chomhairle agreed to continue the meeting beyond 8 p.m. and agreed unanimously that the meeting would finish at 8.30 p.m.

9.9 MURPHY'S FARM AND BISHOPSTOWN HOUSE

An Chomhairle approved the report of the Director of Services dated 15th February 2007 on the following motion which was referred to the Committee by An Chomhairle.

'That Cork City Council would immediately as part of the overall development of Murphy's Farm and Bishopstown House carry out a development programme of works to include complete resurfacing of the parking area and to improve the road surface in the area adjacent to the house.'

(Proposer: Cllr J. Buttimer 06/561)

The report of the Director of Services stated that temporary repairs to the surface of the parking area in the Courtyard were carried out in early February. Improvement works to the Courtyard, car park, public lighting and footpaths will be considered as part of the overall development of Murphy's Farm.

Details of the proposed development works will be submitted to the June Functional Committee meeting for consideration.

9.10 LIGHTING & FOOTPATHS – BISHOPSTOWN HOUSE

An Chomhairle approved the report of the Director of Services dated 15th February 2007 on the following motion which was referred to the Committee by An Chomhairle.

'Upgrade courtyard and car park; provide adequate lighting and footpaths at Bishopstown House, Murphy's Farm, Bishopstown" Bishopstown House and the scout hall attached are used by many groups especially young boy scouts, youth club members, tennis club members etc and the courtyard and car parks are in a very dangerous condition due mainly to large pot holes full of water. Children have to find their way around these obstacles in the dark as the public lighting is totally inadequate. High visibility lighting is necessary from a safety viewpoint and also to discourage anti social behaviour in the area. It is imperative these works are carried out as a matter of urgency.'

(Proposer: Cllr. M. Shields 07/015)

The report of the Director of Services stated that temporary repairs to the surface of the parking area in the Courtyard were carried out in early February. Improvement works to the Courtyard, car park, public lighting and footpaths will be considered as part of the overall development of Murphy's Farm.

Details of the proposed development works will be submitted to the June Functional Committee meeting for consideration.

9.11 CORK CITY – TOURIST HOT SPOT

An Chomhairle agreed to defer this item to the next meeting of An Chomhairle.

9.12 THE RESERVOIR
